- **Customize the experience on representatives' view**
- **Accessible worldwide & guarantee proper access rights**

Who can access the Platform?



Public information

- **Open to everyone**
- **Access is channelled also through the IFAD website**

Restricted information

- **Shown only to authorized users**
- **Access is granted by the Office of the Secretary respecting accreditation status, meeting compositions, official mailing lists and attendance to meeting sessions**

What is 'public' on the Platform?



- **List of IFAD Member States**
- **Composition and short description of GB meetings**
- **Calendar of official meetings and events**
- **Public news and documentation of GB meeting sessions**
- **President's newsletter and other announcements or documents for public audience**
- **Frequently asked questions**

What is 'restricted' on the Platform?



- **Information of List and Sub-list Convenors**
- **Information on current chairmanship of GB meetings**
- **List of accredited representatives to GB meetings**
- **News and documentation of GB meeting sessions for authorized representatives only (e.g. Audit Committee)**
- **Announcements and documents non meeting-related for authorized users only**

“My Area”



This is your dedicated space to consult data and events related to you or your country. Such as your:

- **Contact details as currently used by the Fund**
- **Upcoming meeting and events (including their news and documentation)**
- **Country profile and official representatives data**
- **Country membership to GB meetings and the mailing lists used by the Fund for your country**
- **E-mail notifications settings**

What makes it “Interactive”



- **Interaction with other IFAD applications**
- **Complexity of access and users' rights**
- **Email alert notifications system**
- **Representatives being able to:**
 - **Request update of records or pre-registration to meetings and events**
 - **Modify their own e-mail alert settings**
 - **Post comments on selected Replenishment documents**
