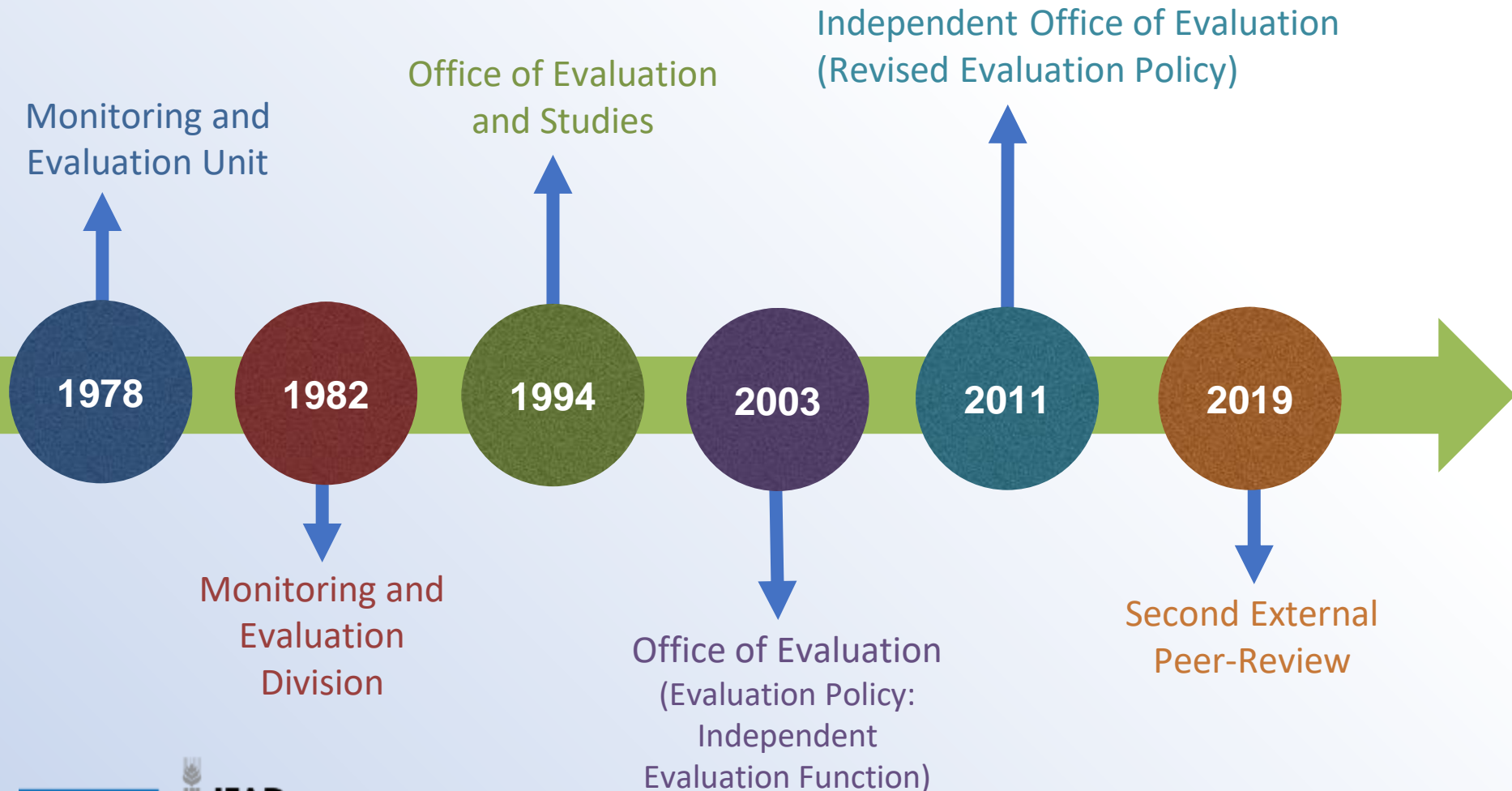

Evaluation Policy 2011: main principles



- **Independence:** evaluation should be impartial and free of undue pressure on its work programme, budget, staffing, disclosure, etc.
- **Accountability:** for operational performance and results
- **Learning:** establishing effective feedback loops to improve performance
- **Partnership:** for a transparent and informed process
- **Credibility:** rigorous and evidence-based analysis
- **Utility:** to ensure timeliness of evaluation recommendations

Implementation procedures

- IOE Director reports to Executive Board
- EB appoints and removes IOE Director
- Evaluation Committee supports EB on evaluation matters
- President's operational authority over IOE staff and consultants delegated to IOE Director
- IOE Work Programme and Budget to be approved by EB and GC
- Evaluation reports issued directly by IOE without prior external clearance

How we operate: The Evaluation Manual



- ✦ Contains the **core methodology** used by IOE in conducting evaluations
- ✦ **Guides staff and consultants** involved in evaluation work
- ✦ Available in **English, French, Spanish and Arabic**

External Peer Review 2019

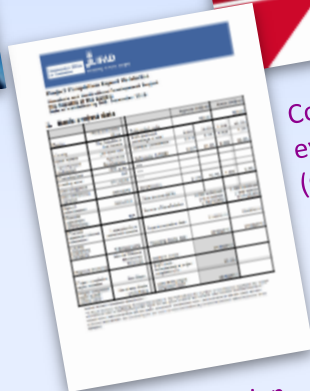
- Conducted by the Evaluation Cooperation Group of the Multilateral development Banks
- Key recommendations:
 - a) Revise the Evaluation Policy to address the whole evaluation system (self and independent), while reaffirming the importance of the independent evaluation function
 - b) Revise ToRs of the EC to ensure full oversight on evaluation system IFAD-wide
 - c) Revisit IOE product mix
 - d) Management to review its self-evaluation products
 - e) Multi-year evaluation strategy to implement the Evaluation Policy

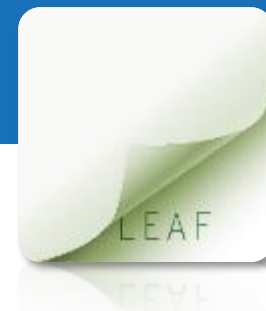

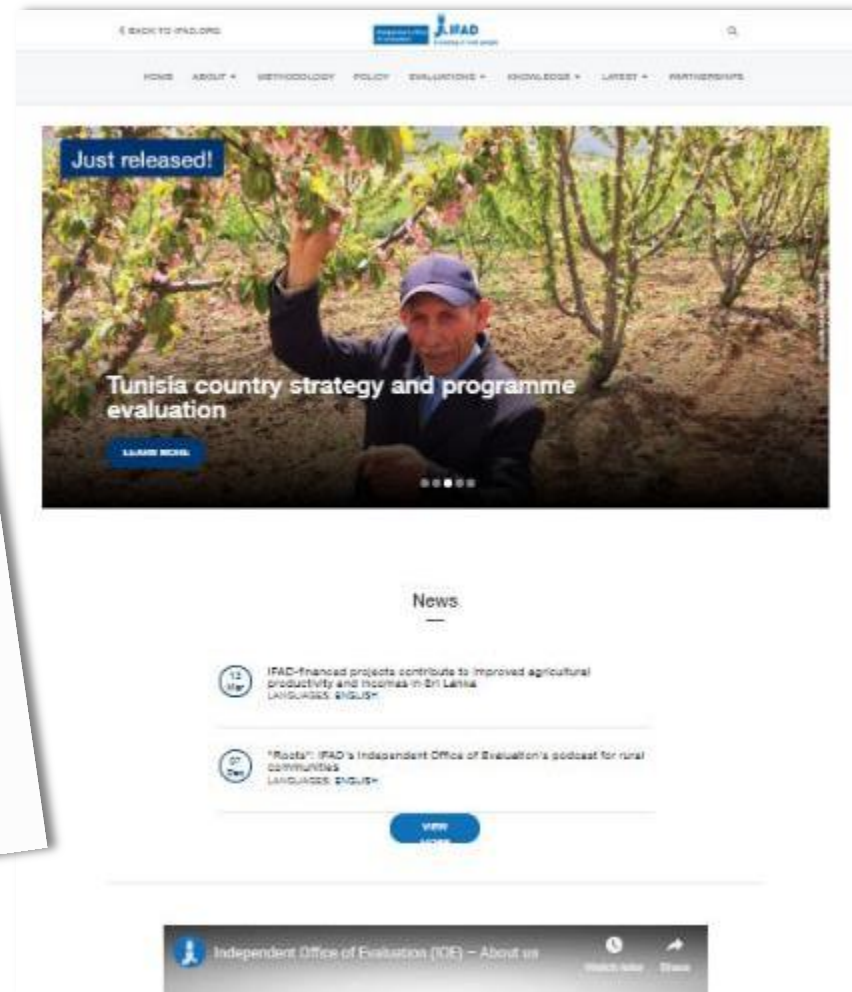
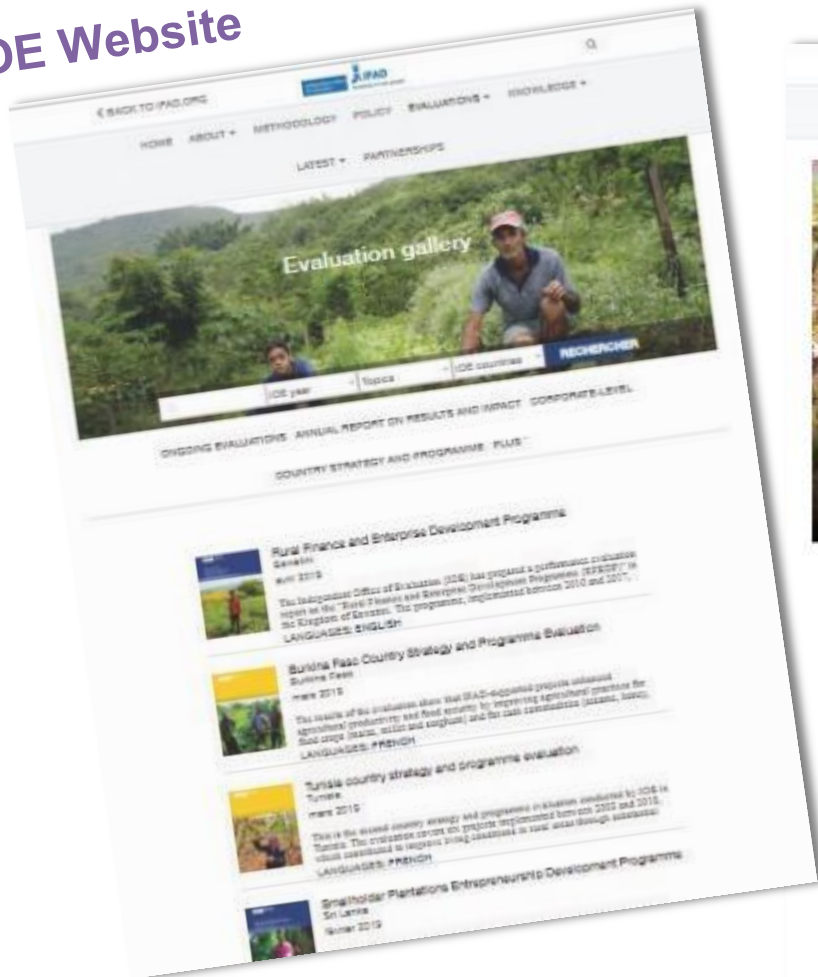
