2. Dialogue on Strategy, Priorities and Targets








# IFAD13: A framework for investing in rural resilience for a food secure future




## Timeline of IFAD13 Sessions and Pledging



#### Other key elements:

- All Member States are strongly encouraged to pledge, and pledges can be announced at any time.
- Votes will be created for IFAD13 six months after approval of report and resolution (August 2024).
- Votes are allocated upon payment (payment can be upfront or scheduled during 2025-2027).
