### Member States Interactive Platform (MSIP) Access and Settings

The <u>Member States Interactive Platform</u> aims to facilitate the exchange of information and communications between the Fund and its representatives with respect to IFAD governing body meetings and other formal and informal events. General information is available to the public, but only authorized users can access restricted information and documentation.
