Report of the Chairperson of the Evaluation Committee on the country visit to Mozambique

Background and objectives

- 1. In line with its terms of reference, the Evaluation Committee undertook a country visit to Mozambique from 24 to 28 May 2010. All members apart from France and Ireland took part in the visit. IFAD was represented by the Director of the IFAD Office of Evaluation (IOE); the Director of the Eastern and Southern Africa Division (ESA); the Senior Portfolio Manager representing the Associate Vice-President, Programme Management Department; the Mozambique Country Programme Manager; and other staff. The Ambassador of Mozambique to Italy accompanied the Committee throughout its visit to the country.
- 2. The overall objective of the country visits is to gain knowledge and experience of IFAD's evaluation work and operations in the field, thereby enabling the Evaluation Committee to provide more informed guidance on evaluation matters to the Executive Board, Management and IOE, and enhance members' competence in this particular area.

Programme of the annual visit

3. The Committee participated in the IFAD Country Programme Evaluation National Round-table Workshop on 24-25 May held in Maputo. Following that, it travelled to Sofala Province to visit three IFAD-funded operations: the Sofala Bank Artisanal Fisheries Project; the Rural Finance Support Programme; and the Agriculture Support Programme, which supports the National Programme for Agricultural Extension.

Country programme evaluation (CPE) national round-table workshop

- 4. The workshop was organized by the Government of Mozambique and IOE, with the collaboration of ESA. The Government took the lead in coordinating the event, which is a manifestation of the importance it attributes to its partnership with IFAD. More than 100 persons took part in the workshop, including government officials, project directors, NGOs and civil society representatives, bilateral and multilateral aid agencies, private-sector representatives, Evaluation Committee members, and IFAD Management and staff. The workshop was inaugurated by the Mozambique Minister of Fisheries, and the Governor of the Bank of Mozambique delivered the closing statement of the event (see annex for workshop agenda).
- 5. An issues paper was prepared by IOE in collaboration with the Government and ESA as background for the workshop discussions. This paper was circulated together with the main CPE ahead of the event. The issues paper was organized around three themes: (i) engaging private and civil society organizations in IFAD-supported programmes in Mozambique; (ii) targeting aspects in future interventions in Mozambique; and (iii) reflection on existing areas of intervention of IFAD in Mozambique relevance and options for improvement. The paper effectively captured the main learning elements of the CPE and raised a number of pertinent points to be considered in the development of the new Mozambique country strategic opportunities programme (COSOP), which will be presented to the Executive Board for consideration in the near future.
- 6. The Committee found the workshop to be well organized, with adequate time and space for presentations and discussions in both plenary sessions and working groups. It provided a useful forum for the validation of the CPE's findings and for discussion of key issues and lessons learned. It also served to identify country context issues that would be useful for the preparation of the forthcoming COSOP;

- and to collect valuable inputs for the CPE's agreement at completion point, which, in fact, was signed in Maputo by the Government at the end of the workshop. The Committee was satisfied with the inclusive nature of the workshop, which brought together IFAD's varied clientele.
- 7. In the closing session of the workshop, the Chairperson of the Evaluation Committee offered his reflections on the IFAD-Government partnership in Mozambique. He also underlined a number of issues that merit attention in the development of the new COSOP. These include the importance of promoting innovations in agriculture technology and their scaling up for wider impact on rural poverty; the need for achieving greater gender equality and women's empowerment in Mozambique; the opportunities for further strengthening partnership and synergies with the African Development Bank; the importance of promoting decentralization for bringing decision-making, resource allocation and implementation closer to the grass-roots level; and the need to find ways and means to address the challenges posed by climate change to small farmers and fishers.

Field visit

- 8. The field visit to Sofala Province was organized by the Government (under the overall aegis of the Ministry of Planning and Development) and ESA. It provided members with a good opportunity to exchange views and interact with different stakeholders at the project level including provincial authorities, implementing partners, beneficiaries and project staff. Before the Committee travelled to Sofala, ESA provided it with an overview of the projects included in the field visit and the main activities undertaken.
- 9. From the field visit, it was evident that IFAD is a respected partner that has a valuable role to play in rural poverty reduction in the country. Meeting with groups of women and fishing communities revealed that IFAD-funded projects are making an important contribution to promoting better incomes and livelihoods. However, the challenges of working in remote areas with a relatively low population density, weak infrastructure and limited access to markets are important constraints that need greater attention in the future.
- 10. The field visit gave the Committee a further opportunity to appreciate the coverage, both in terms of the number of operations and geographic area, of the IFAD-funded portfolio in Mozambique. While the Committee recognized the good and hard work of the national country officer based in Mozambique, it was felt that the Mozambique country staff are stretched given the diversity of functions they are required to discharge. It was also evident from the field visit and interactions with various stakeholders that the country presence will need to be further strengthened if IFAD is to play a more effective role in combating rural poverty in the country. A stronger and more permanent country presence would be commensurate with the size and importance of the Mozambique portfolio, and enable IFAD to more actively participate in policy dialogue processes, knowledge management and partnership-building activities.
- 11. There were aspects related to the logistics of the field visit to Sofala that created some concern to members, including the long distances of travel, which did not allow sufficient time for interactions with communities and visits to project sites.

Bilateral meetings

12. The Committee also held bilateral meetings in Maputo just before and after the commencement of the CPE national round-table workshop with: (i) high-level government representatives, including the Minister of Fisheries, Minister of Agriculture, Vice-Minister of Finance, and the Governor of the Bank of Mozambique;

- (ii) the United Nations Country Team; and (iii) selected representatives from the National Agriculture Development Programme (PROAGRI)² donor working group.
- 13. In bilateral meetings, representatives of the Government underlined, among other issues, the importance of IFAD as one of the major players in the agriculture sector in the country. The Government also emphasized the need for capacity-building at the provincial and district levels, in order to ensure timely delivery of services to promote sustainable smallholder agriculture and rural development. In this regard, in particular, Committee members took note of the Government's commitment to post key officials in selected districts to contribute to participatory planning and implementation of activities.
- 14. The United Nations Country Team meeting was useful in clarifying the importance of the "Delivering as One" United Nations pilot programme, which has been successfully implemented in the country. The United Nations officials present at the meeting also highlighted the positive effects the pilot has had on the Mozambique Government and related agencies. For example, the pilot has contributed to a more coordinated and harmonized approach to broader development planning and resource allocation. Finally, the meeting with PROAGRI focused on ways and means to further streamline donor policies and projects in the country.
- 15. In closing, the Evaluation Committee expresses its deepest appreciation for the arrangements made during the field visit to Sofala and for every effort carried out by the Government in making the Committee's 2010 country visit a success. The discussions with the various stakeholders including beneficiaries, project officials, partner organizations and government representatives were informative and useful. The Committee pays tribute to and acknowledges the invaluable participation of and interaction with the Ambassador of Mozambique, who accompanied the Committee throughout its visit to the country.
