## Amendment to dates for Executive Board sessions in April and September 2012

- 1. At its 101<sup>st</sup> session in December 2010, the Executive Board approved the calendar for 2012 sessions of the Executive Board.
- 2. The dates for the 105<sup>th</sup> and 106<sup>th</sup> session of the Executive Board, previously set as 11 and 12 April 2012 and 12 and 13 September 2012, will need to be changed owing to unforeseen scheduling conflicts. In consultation with the secretariats of the Food and Agriculture Organization of the United Nations (FAO) and the World Food Programme (WFP), the following new dates are proposed:
  - 105<sup>th</sup> Session Tuesday, 17 and Wednesday, 18 April 2012
  - 106<sup>th</sup> Session Thursday, 20 and Friday, 21 September 2012

While specific dates are proposed, Executive Board representatives will note that the entire week has been reserved on the Calendar of FAO/IFAD/WFP governing bodies and other main sessions, to ensure flexibility in order to accommodate the workload of the meeting and surrounding events such as informal seminars held in conjunction with the Board session.
