# Application for non-original membership

- 1. By a letter dated 14 August 2012, signed by His Excellency Sprent Dabwido, President of the Republic of Nauru, the Republic of Nauru applied for membership with the International Fund for Agricultural Development, in accordance with Articles 3.1(a), 3.2(b) and 13.1(c) of the Agreement Establishing the International Fund for Agricultural Development ("Fund").
- 2. The Republic of Nauru has been a member of the United Nations since 14 September 1999.
- 3. The Republic of Nauru wishes to make a contribution to the Fund, in accordance with Article 4 of the Agreement Establishing IFAD, of AUD 1,000 upon approval of its membership application.

## The Governing Council,

**Taking into account** Articles 3.1 (a), 3.2(b) and 13.1(c) of the Agreement Establishing IFAD and Section 10 of the By-laws for the Conduct of the Business of IFAD;

**Considering** that non-original Members of the Fund shall be those States members of the United Nations or any of its specialised agencies that, after the approval of their membership by the Governing Council, become parties to the Agreement Establishing the International Fund for Agricultural Development by depositing an instrument of accession with the Secretary General of the United Nations;

**Considering** that the Republic of Nauru, has been a member of the United Nations since September 1999;

**Considering** therefore that the Republic of Nauru is eligible for membership in the Fund;

**Having considered** the application for non-original membership by the Republic of Nauru transmitted to the Council in document GC \_\_\_\_\_, and the recommendation of the Executive Board that the Republic of Nauru should be admitted to membership in the International Fund for Agricultural Development;

**Taking note** of the contribution amount proposed by the Republic of Nauru, AUD 1,000, upon approval of its membership application;

Approves the membership of the Republic of Nauru;
