Report on the status of contributions to the Ninth Replenishment of IFAD's Resources

1. For the information of the Executive Board, the present document contains the following annexes:
 - Annex I Summary of the status of contributions to the Ninth Replenishment as at 30 September 2013
 - Annex II Status of Member States' contributions to the Ninth Replenishment as at 30 September 2013
2. As shown in the summary table in annex I of this report, total pledges as at 30 September 2013, including complementary contributions, amounted to US\$1,391 million equivalent, corresponding to 93 per cent of the Ninth Replenishment target of US\$1.5 billion. Member States that have not yet pledged and those intending to increase their contribution are urged to communicate their pledges to the Fund as soon as possible.
3. Annex II shows the details of individual Member States' contributions to the Ninth Replenishment as at 30 September 2013.
4. As at 30 September 2013, instruments of contribution deposited amounted to US\$1,263 million making up 90 per cent of total pledges. Member States whose instruments of contribution have not yet been deposited are requested to take the necessary action.
5. As at 30 September 2013, payments for the Ninth Replenishment received from Member States amounted to US\$738 million equivalent, or 53 per cent of pledges.
6. During the same period, for IFAD8, pledges received amounted to 89 per cent of the Replenishment target, instruments of contribution deposited amounted to 83 per cent and payments received amounted to 52 per cent of the level of pledges; for IFAD7, pledges received amounted to 89 per cent of the Replenishment target, instruments of contribution deposited amounted to 83 per cent and payments received amounted to 38 per cent of the level of pledges.

No contribution or payment was due by IFAD to Yugoslavia at the time of its dissolution, nor by Yugoslavia to IFAD.

^k Canada's pledge includes a core contribution of CAD 75 million and complementary contribution of CAD 19.8 million for the Adaptation for Smallholder Agriculture Programme.

^l Italy's Instrument of Contribution was received in September 2013 and as at the date of the report, was still subject to an internal clearance process.
