Report on the Tenth Replenishment of IFAD's Resources

1. Adoption. Resolution 186/XXXVIII on the Tenth Replenishment of IFAD's Resources (IFAD10) was adopted by the Governing Council on 16 February 2015. The period of IFAD10 is defined in the resolution as "the three-year period commencing 1 January 2016".
2. Additional pledges. Pledges made as at the date of adoption of the resolution, that is, 16 February 2015, amounted to US\$933,426,946, including unrestricted complementary contributions. As at 16 August, pledges amounted to US\$1,149,778,066, including unrestricted complementary contributions. Debt Sustainability Framework (DSF) compensation becomes effective as of the Tenth Replenishment. As a result, Member State contributions to IFAD10 were adjusted to account for DSF compensation amounting to US\$2,984,161. The status of pledges to IFAD10 as at 16 August 2015 is set out in annexes I and II.
3. Target. Paragraph I(c) of resolution 186/XXXVIII established the target level of IFAD10 at US\$1.44 billion. Paragraph I(e) of resolution 186/XXXVIII specified that the structural gap between total pledges and the target level may not exceed fifteen per cent (15 per cent). As indicated in paragraph 2 above, and as set forth in annexes I and II, pledges as at 16 August 2015 amounted to US\$1,149,778,066, corresponding to 79.8 per cent of the US\$1.44 billion target. In accordance with the decision of the Governing Council at its twenty-ninth session, the President of IFAD has the authority to adjust the target level on the basis of pledges received as at 16 August 2015 so that the total amount of the pledges received as of that date represents 85 per cent of the adjusted target. Accordingly, the President of IFAD, by virtue of the authority conferred on him by the Governing Council, has adjusted the target level to US\$1,352,680,077.
4. Creation of new votes. Under the voting system introduced on 20 February 1997 by resolution 86/XVIII, new votes are created for each replenishment. These votes are allocated on a basis similar to the original and replenishment votes and are divided between membership and contribution votes. Resolution 186/XXXVIII provided that votes for IFAD10 would be calculated on the basis of aggregate pledges received within the six months following the resolution's adoption on 16 February 2015, that is, by 16 August 2015.
5. Of the total pledges of US\$1,152,762,227 received as at 16 August, pledges amounting to US\$82,621,240 were in the form of unrestricted complementary contributions, pledged in accordance with paragraph II(b)(iv) of resolution 186/XXXVIII, and thus do not count towards the creation of votes. This results in a balance of US\$1,070,140,987 for the creation of Tenth Replenishment votes.
6. Under the formula stipulated in article 6, section 3(a)(ii) of the Agreement Establishing IFAD, 100 replenishment votes are created for every US\$158 million of convertible currency contributions pledged. Thus, for IFAD10, the amount of US\$1,070,140,987 creates 677.305 replenishment votes, which are broken down into membership votes (285.865) and contribution votes (391.440). According to article 6, section 3(a)(iii) of the Agreement Establishing IFAD, List C shall receive one third of the total votes as membership votes. The total of IFAD10 votes is fixed and will not be altered by any change in the membership of the Fund or further pledges to IFAD10.
7. The membership and contribution votes became effective as from 16 August 2015. A table containing the calculation of membership and contribution votes, including Tenth Replenishment votes, is attached as annex III. Although the number of Tenth Replenishment votes is fixed at a total of 677.305, the distribution of contribution votes (391.440) among Member States will change as payments of contributions are received. Thus all Member States contributing to IFAD10,

including those announcing their pledges after 16 August 2015, will receive a share of IFAD10 contribution votes in proportion to their respective share of paid-in contributions to the Replenishment. Annex III presents the voting rights of Member States as at 16 August 2015.

8. Status of contributions. Annexes I and II set out the status of pledges, instruments of contribution deposited and payments in cash and promissory notes for IFAD10 as at 16 August 2015.
9. As at that date, pledges to IFAD10 amounted to US\$1,149,778,066 equivalent, corresponding to 85 per cent of the IFAD10 target of US\$1.35 billion. Member States that have not yet pledged and those intending to increase their contribution are urged to communicate their pledges to the Fund as soon as possible.
10. In accordance with paragraph IV(a) of resolution 186/XXXVIII, IFAD10 will become effective on the date "upon which instruments of contribution or payments made without an instrument of contribution relating to the additional contributions from Members referred to in section II of this Resolution have been deposited with or received by the Fund in an aggregate amount equivalent to at least 50 per cent of the pledges as communicated by the President to Members pursuant to subsection I(d) of this Resolution." As at 16 August 2015, instruments of contribution and payments amounted to US\$385,091,287 or 33 per cent of the total pledges of US\$1,149,778,066. Member States are urged to deposit instruments of contribution as soon as possible so that the Replenishment may become effective.
11. It should be noted that, as at 16 August, pledges for IFAD10 core contributions amounted to US\$1.07 billion, while during the same period for IFAD9, pledges received amounted to US\$1.04 billion, and for IFAD8 US\$0.97 billion.
