1. Opening of the session

The thirty-ninth session of the Governing Council will be held on Wednesday, 17 February and Thursday, 18 February 2016.

2. Adoption of the agenda

 of the By-laws for the Conduct of the Business of IFAD, the Governing Council will
 be invited to consider document GC 39/L.4, which will contain the financial
 statements of IFAD for 2014, the report of the external auditor and the external
 auditor's independent attestation on internal controls over financial reporting. The
 Executive Board reviewed the statements at its 114th session in April 2015 and
 recommended that they be submitted for approval by the Governing Council.

 - The budgets of IFAD and the Independent Office of Evaluation of IFAD (IOE) for 2016, as recommended by the Executive Board for approval by the Governing Council, will be presented in document GC 39/L.5, together with a draft resolution thereon. This document will also report on participation by IFAD in the Heavily Indebted Poor Countries (HIPC) Debt Initiative and on the implementation of IFAD's performance-based allocation system (PBAS), for the information of the Council.
