

Planned Global, Regional and Country Activities as at 22 October 2019

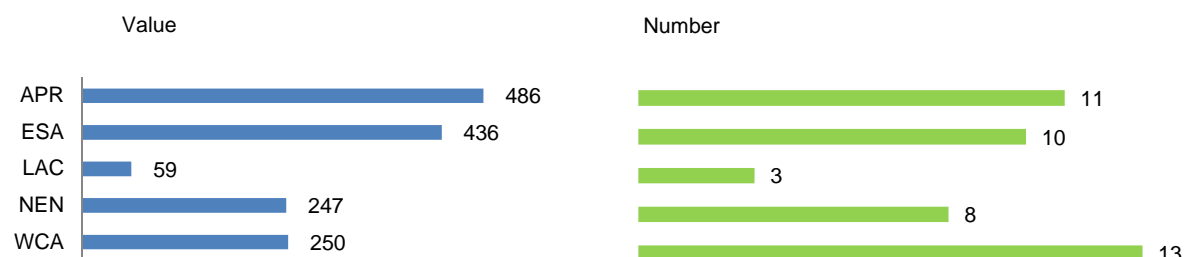
1. The information provided in this document is intended to enable representatives to keep abreast of developments in IFAD's country strategy, programme, project and grant pipeline and, if they wish, to comment on planned operations at an early stage of the development cycle.
2. Table 1 provides a comprehensive listing of all projects and programmes that have entered the pipeline after project concept note approval.
3. Table 2 provides an indicative list of planned country strategic opportunities programmes (COSOPs) that will be submitted to the Executive Board for review.
4. Table 3 reports on the official pipeline of global, regional and county-specific grants.
5. As at 22 October 2019, 48 country strategy notes had been approved and disclosed on IFAD's website (under the respective country web pages at www.ifad.org) for the following countries: Afghanistan, Angola, Belize, Bhutan, Botswana, Burkina Faso, Cabo Verde, Cameroon, Central African Republic, Chad, Comoros, Côte d'Ivoire, Cuba, Djibouti, Eritrea, Eswatini, Gabon, Grenada, Guatemala, Guinea, Guinea-Bissau, Guyana, Iraq, Jordan, Kiribati, Kyrgyzstan, Lebanon, Lesotho, Liberia, Malaysia, Mali, Mauritania, Montenegro, Papua New Guinea, Sao Tome and Principe, Samoa, Senegal, Seychelles, Sierra Leone, South Africa, South Sudan, Syrian Arab Republic, Tajikistan, Togo, Tonga, Tunisia and Yemen, Zimbabwe.

Overview

6. Interventions during the first and second year of the Eleventh Replenishment of IFAD's Resources (IFAD11) will continue to focus on the priority areas and strategic objectives (SOs) of the IFAD Strategic Framework 2016-2025. Investments will feature activities that lead to: (i) an increase in poor rural people's productive capacities (SO1); (ii) increased benefits from market participation (SO2); and (iii) strengthened environmental sustainability and climate resilience of economic activities (SO3). These SOs will be embedded in the relevant country strategies and project concept notes.
7. This document includes financing proposals in support of a total of 45 projects and programmes currently in IFAD's official pipeline for 2019-2021, amounting to US\$1.48 billion (table 1). Figure 1 illustrates the value and number of projects in the official pipeline in each geographical region.
8. New interventions will be added to the pipeline for approval in 2020-2021, once concept notes for projects and global, regional and country specific grants are approved by the Operational Strategy and Policy Guidance Committee.
