Addendum

- 1. The attention of the Executive Board is drawn to the following addendum to the IFAD Strategy on Diversity, Equity and Inclusion: Annual Report (EB 2022/135/R.21).
- 2. This document provides additional details on IFAD's response to Member States, specifically with respect to paragraphs 12 and 18 and appendix I of the annual report. To this end, it offers supplementary narrative and disaggregated data on specific non-staff categories, notably interns, junior professional officers (JPOs) and staff on loan, by gender and nationality. The information provided in the tables is valid as of 31 March 2022, unless otherwise specified.

I. Breakdown by nationality of IFAD interns, JPOs and staff on loan

Interns

- 3. IFAD's internship programme offers a unique learning experience to recent graduates or students specializing in areas relevant to IFAD's mission, and who can provide IFAD with particular assistance in various professional fields.
- 4. As of 31 March 2022, there were 67 interns in IFAD, the majority of whom (64.2 per cent) were nationals of List A countries. More than one in three interns (35.8 per cent) were from List B and C countries (1.5 per cent and 34.3 per cent, respectively). Most interns are nationals of China, Italy and the United States. Tables 1 and 2 provide a breakdown by List, location and nationality.
- 5. In general, IFAD's internships are not managed through bilateral agreements with Member States or universities. However, in the last five years, IFAD has signed three bilateral agreements: one with the Korean Overseas Agricultural Sector Intern Scholarship Programme, signed in 2017, and two, signed in 2019 and 2020, with the China Scholarship Council and Tsinghua University. In general, bilateral agreements do not foresee a limit to the number of interns at IFAD at any given time, although the agreement with the China Scholarship Council foresees up to 20 young graduates each year. At the time of writing, 14 Chinese interns and 13 interns from the Republic of Korea have been engaged through these agreements.
- 6. Over the past five years, 783 interns have worked at IFAD. Table 3 provides a breakdown by nationality.

Junior professional officers

- 7. Staff included in this category are junior professionals recruited under bilateral agreements between IFAD and Member States. They are usually nationals of a donor country but may also be nationals of developing countries sponsored by donors.
- 8. As of 31 March 2022, there were 23 JPOs working at IFAD, of whom 21 were nationals of List A countries (91.3 per cent), and the remainder from List C countries sponsored by France and the Netherlands. Table 1 provides a breakdown by List and location.
- 9. IFAD has JPO agreements with Belgium, China, Denmark, Finland, France, Germany, Italy, Japan, Republic of Korea, the Netherlands, Norway, Sweden, Switzerland and the United States. These agreements do not specify a maximum number of JPOs that can be funded at any given time.

- Tables 1 and 2 below present a breakdown by nationality of IFAD JPOs as of 31 March 2022. Since then, two JPOs from China have been appointed (in April 2022) and 10 more JPOs are expected to join by the end of 2022 (three from the Netherlands, two from Germany, and one from France, Italy, Japan, Norway and Switzerland, respectively).
- 11. Over the past five years, 51 JPOs have been employed at IFAD. Table 4 provides a breakdown by nationality.

Staff on loan

- 12. Staff included in this category are individuals working for IFAD under specific partnership or other agreements, fully or partially sponsored by governments or government institutions.
- 13. IFAD has special programme officer (SPO) agreements in place with Japan, the Republic of Korea and Sweden. In addition, it has agreements with the Ministry of Finance of China, the Kuwait Fund for Arab Economic Development and the Agence Française de Développement.
- 14. As of 31 March 2022, there were five staff on loan at IFAD. Three were nationals of List A countries, one from List B and one from sub-List C2. All staff on loan are based at headquarters. One Japanese SPO is expected to join IFAD in the second half of 2022. Tables 1 and 2 provide a breakdown of staff on loan by List, location and nationality.
- 15. Over the past five years, 12 staff on loan have been employed at IFAD. Table 4 provides a breakdown by nationality since 1 April 2017.

III. Breakdown by gender
