In accordance with regulation XII of the Financial Regulations of IFAD and section 9 of the By-laws for the Conduct of the Business of IFAD, the Governing Council will be invited to consider this document, which will contain the consolidated financial statements of IFAD for 2021, the report of the external auditor thereon and the external auditor's independent attestation on the Management assertion report on the effectiveness of internal controls over financial reporting. The Executive Board considered these documents and approved their submission to the Governing Council for approval, through vote by correspondence, in May 2022.

# 8. IFAD's 2023 results-based programme of work, regular and capital budgets and medium-term strategic budget outlook for 2024–2025, and the Independent Office of Evaluation of IFAD's results-based work programme and budget for 2023 and indicative plan for 2024–2025, and the HIPC and PBAS progress reports

As recommended by the Executive Board, the budgets of IFAD and the Independent Office of Evaluation of IFAD (IOE) for 2023 will be presented for the approval of the Governing Council, together with a draft resolution thereon. Additionally, the medium-term strategic budget outlook for IFAD for 2024-2025, IOE's indicative work plan for 2024-2025 as well as the progress reports on IFAD's participation in the Heavily Indebted Poor Countries (HIPC) Initiative and on the implementation of IFAD's performance-based allocation system (PBAS) will be presented for the information of the Council.
