Country visits of the IFAD Executive Board 2025–2027 and date of visit to Tunisia

- 1. The Office of the Secretary, with the assistance of the Programme Management Department, is responsible for managing the field visit programme for the Executive Board in accordance with the recommendation contained in the Peer Review of IFAD's Office of Evaluation and Evaluation Function, which was endorsed by the Executive Board at its ninety-ninth session (EB 2010/99/R.6).
- 2. In December 2012, the Executive Board approved a new modality for country visits, which required the Board to decide on the destination of future annual visits. Under the new procedures, country visits would be open to participation by Executive Board members that were not members of the Evaluation Committee. Nine members would participate in the visits: four from List A, two from List B and three from List C. The Lists would decide on the participation, and the visits would be fully funded by IFAD. The Board also stipulated that a maximum of three additional members of the Executive Board that were not members of the Evaluation Committee could join the country visits on a self-financing basis. These new rules were applied for the annual country visits from 2014 onwards.
- 3. The following criteria determine the country selection: (i) an ongoing country programme is present (ideally with a mix of lending and non-lending activities); (ii) the country has been subject to a country-level evaluation or a completion report has been produced on the results-based country strategic opportunities programme within the previous two years; (iii) at least two of three country visits over a replenishment period should be to a least developed country (LDC) or a country with a fragile situation; and (iv) adequate regional rotation must be ensured in country selection.
- 4. In light of the above and in consultation with the Independent Office of Evaluation of IFAD, the updated plan for country visits in 2025-2027 is the following:

- 5. The visits to Haiti and India were approved at the 136th session of the Executive Board. The rolling plan is hereby updated to include the Democratic Republic of the Congo as the destination for 2027.
- 6. The Democratic Republic of the Congo is currently categorized as a least developed country and as a country with a fragile and conflict-affected situation. It is the third most populated country in sub-Saharan Africa and has the largest area of arable land in the continent, estimated at 80 million hectares. At present 10 per

- cent of this land is being cultivated. Despite its huge reserves of natural resources, the Democratic Republic of the Congo is one of the poorest countries in the world.²
- 7. The West and Central Africa region hosts 31 per cent of the world's extreme poor, of whom 65 per cent live in the Democratic Republic of the Congo and Nigeria. IFAD's effectiveness in the region is therefore greatly influenced by the results and impact achieved in the Democratic Republic of the Congo. A COSOP completion review is planned for 2024 and a two-year extension of the current COSOP is already envisaged. The overall size of IFAD's ongoing portfolio in the country is US\$410 million, including cofinancing; of this, IFAD financing amounts to approximately US\$117 million, sourced from both the performance-based allocation system (PBAS) and the Borrowed Resources Access Mechanism (BRAM).
- 8. The country's portfolio currently accounts for about 5 per cent of the overall portfolio in the West and Central Africa region. This includes the recently approved Empowerment through Nutrition-Sensitive, Inclusive and Resilient Agricultural and Rural Entrepreneurship (AVENIR) project, which focuses on promoting rural enterprises, and the ongoing Inclusive and Resilient Rural Development Programme (PADRIR) and the Agricultural Support Project in North Kivu (PASA-NK), which focus on productivity and sustainable agricultural value chain development. The geographical focus is on remote rural areas, in particular the provinces of North Kivu, Kasai, Maniema, Kwilu and Mai-Ndombe and the rural periphery of Kinshasa, with the aim of decreasing dependency on food imports, promoting employment for women and youth, and improving the incomes of rural households.
- 9. Due to the COVID-19 pandemic, the visit to Egypt planned for 2020 was postponed to 25 to 29 October 2021. The dates for the visit to Sierra Leone were approved as 21 to 25 November 2022. The dates for this year's visit to Uganda are 27 November to 1 December. For the visit to Tunisia in 2024, the common calendar of meetings of permanent representatives³ has been consulted and possible dates have been identified as 4–8 November.
- 10. The Executive Board is therefore invited to approve the updated rolling plan 2025–2027 and the dates for the visit to Tunisia in 2024.
