We count on your support, as it is the most critical factor in achieving our shared objectives.

I want to thank Panama a second time for their welcoming words with respect to our new regional office. All of IFAD looks forward to a new period of collaboration.

Today I heard loud and clear support for our efforts on a targeted use of innovation and how it should impact IFAD's delivery.

As several of you indicated, innovation can take various forms – and it doesn't always need to be high-end technology. This is why our approach aims to take advantage of context-appropriate technology and knowledge, new financial instruments, and South-South and Triangular Cooperation.

The directions and suggestions you have given us, as well as the knowledge and support from your Governments on innovation, will be crucial for achieving IFAD's goals in the years to come.

Your recommendations to further incorporate innovations in IFAD operations and align with the work of other IFIs and the RBAs are well noted.

I would also like to express my appreciation to the Staff Association for its statement. IFAD Management remains committed to ongoing constructive engagement to address some of the issues raised.

Before we close, allow me to express my gratitude to Ms Lamia Ben Redouane of Algeria, as I understand this will be her last Board session. Since her nomination as Deputy Permanent Representative in September 2019, Lamia has participated actively in

numerous ways, including in sessions of the Governing Council, Executive Board, Audit Committee and replenishment Consultation and in the Convenors and Friends' meetings. I want to thank her for her dedication and wish her all the best for her future endeavours.

Allow me also to express my appreciation to Mr Moisés Morera Martín of Spain, since this will also be his last Executive Board, and to thank him for his support and his friendship throughout these years.

As we conclude this Executive Board meeting, on behalf of IFAD I would like to reiterate our gratitude for your unwavering support and thank you all once more.
