Page 12, paragraph 82 should read:

"I recommend that the Executive Board approve the proposed financing in terms of the following resolution:

RESOLVED: that the Fund shall provide a loan on ordinary terms to the People's Republic of China in an amount of <u>seventy-nine million six hundred</u> <u>and ninety thousand euros (EUR 79,690,000)</u> eighty eight million United States dollars (US\$88,000,000) and upon such terms and conditions as shall be substantially in accordance with the terms and conditions presented herein."
