Report on the status of the Thirteenth Replenishment of IFAD's Resources

1. **Adoption.** Resolution 235/XLVII on the Thirteenth Replenishment of IFAD's Resources (IFAD13) was adopted by the Governing Council at its forty-seventh session on 14 February 2024.
2. **Replenishment target.** Paragraph 3 of the resolution established the replenishment target for core contributions, core additional climate contributions (ACCs), the grant element of concessional partner loans (CPLs) and the discount or credit generated from early encashment of core contributions during the Thirteenth Replenishment at US\$1.875 billion in order to support a target programme of loans and grants of up to US\$3.64 billion, together with other resources of the Fund.
3. **Status of contributions.** As communicated to the Governing Council, pledges made as at 9 February 2024 amounted to US\$1,161,759,854. As at 14 August 2024, the level of pledges of core contributions, core ACCs and the grant element of CPLs amounted to US\$1,402,857,152, equivalent to 75 per cent of the IFAD13 target of US\$1.875 billion.
4. **Effectiveness.** In accordance with paragraph 16 of the resolution, IFAD13 became effective on 14 August 2024. The resolution states that IFAD13 would become effective on the date "upon which instruments of contribution [IOCs] deposited or payments made without an instrument of contribution relating to the additional contributions from Members referred to in section II (Contributions) of this resolution have been deposited with or received by the Fund in an aggregate amount equivalent to at least 50 per cent of the pledges as communicated by the President to Members pursuant to paragraph 8 of this resolution." IOCs or payments made without such instruments being deposited in an aggregate amount of US\$713.7 million, equivalent to 51 per cent of the total pledges of US\$1,402 million, had been received by 14 August 2024.
5. As of the replenishment's effectiveness date, all additional contributions paid to the Fund's resources are to be considered available for operational commitment. Member States that have not deposited their IOCs are urged to do so.
6. **Resource mobilization.** In the year of the Summit of the Future and the 29th United Nations Climate Change Conference of the Parties (COP29), a fully funded IFAD13 will help IFAD deliver on its global ambition: ensuring that the poorest people and the poorest countries are not left behind. Based on current assumptions, Management is expecting, with a reasonable degree of certainty, additional pledges of approximately US\$170 million by late 2024 or early 2025, bringing the total to at least US\$1.57 billion.
7. The target of US\$1.875 billion is achievable within the IFAD13 period if most major donors increase their pledges in line with the IFAD13 scenario (i.e. at least a 30 per cent increase in United States dollar terms compared to their total IFAD12 regular core contribution, plus additional core ACCs and CPLs). Many countries have already met or even exceeded this target. Others have pledged lower increases or have still not pledged. Management continues to advocate for all Member States to contribute in line with the agreed target and reminds all Member States that **pledges can be made or increased at any time during the IFAD13 period.**
8. Closing the gap to reach the target of US\$1.875 billion would ensure full delivery of target operations during the IFAD13 period, with a strong focus on low-income countries and lower-middle-income countries. Member States that have not yet pledged and those intending to increase their contributions are urged to communicate their pledges to the Fund as soon as possible.

9. **Monitoring progress.** Progress towards the targets will continue to be monitored closely. Nevertheless, the figures already demonstrate a high level of political support for IFAD and for IFAD13 given the increased pledges from many donors. As indicated above, 91 Member States have now pledged US\$1.402 billion to IFAD13, compared to US\$1.164 billion from 85 Member States at the same point in IFAD12.
10. **Borrowing.** As per the IFAD13 Resolution, funding may also be raised during the replenishment period through loans from Member States and related state-supported institutions, multilateral development banks, supranational institutions and private institutional investors pursuant to the Integrated Borrowing Framework. CPL pledges were provided by Finland during the IFAD13 Consultation. Discussions are under way with several Member States on CPLs and sovereign borrowing.
11. **Creation of new votes.** Paragraph 26 of resolution 235/XLVII specifies that: "New replenishment votes shall be created in respect of core contributions, ACCs, the grant element of any CPL and the discount or credit generated from early encashment of core contributions provided under the Thirteenth Replenishment (Thirteenth Replenishment Votes) in respect of pledges in each case received as of six months after the date of adoption of this resolution."
12. Under the formula stipulated in article 6, section 3(a)(ii) of the Agreement Establishing IFAD, and the decision of the Governing Council in adopting resolution 235/XLVII, 100 replenishment votes are created for every US\$158 million of convertible currency contributions pledged, with the exclusion of core ACCs. With regard to core ACCs, 50 replenishment votes are created for every US\$158 million of convertible currency contributions pledged.
13. Of the total US\$1,402,857,152 in pledges received as at 14 August 2024, US\$54,374,583 were pledged as core ACCs. Core ACC pledges amounting to US\$21,830,833 did not meet the substitution risk requirements, as set out in annex VII of the Report of the Consultation on the Thirteenth Replenishment of IFAD's Resources, for the generation or allocation of voting rights. Thirteenth Replenishment votes were therefore created on the basis of US\$1,348,482,568 pledges made as core contributions, the grant element of any CPL, and the discount or credit generated from early encashment of core contributions and US\$32,543,700 pledges made as core ACCs.
14. Thus for IFAD13, 863.769 replenishment votes were created; these are broken down into membership votes (371.379) and contribution votes (492.390). According to article 6, section 3(a)(iii), List C shall receive one third of the total votes as membership votes. The total of IFAD13 votes is fixed and will not be altered by any change in the Fund's Membership or further pledges to IFAD13.
15. The membership and contribution votes became effective on 14 August 2024. A table detailing the distribution of membership and contribution votes, including IFAD13 votes as at 14 August 2024, is attached as annex III. Although the number of IFAD13 votes is fixed at 863.769, the distribution of membership votes (371.379) will change if there are any changes to the membership of the Fund while the distribution of contribution votes (492.390) among Member States will change as payments are received. Thus all Member States contributing to IFAD13, including those announcing their pledges after 14 August 2024, will receive a share of IFAD13 contribution votes in proportion to their respective share of payments to the replenishment.
