## THE PROGRAMME

The forty-eighth session of the Governing Council of IFAD (GC48) takes place over two days. The first day, Wednesday, 12 February, is the High-level Segment of the Governing Council with Leaders' Dialogues, while the second day, Thursday, 13 February, is focused on governance matters.

**HIGH-LEVEL SEGMENT.** This will feature keynote addresses, a Centre Stage Event and Leaders' Dialogues with special high-level guests.

**GOVERNANCE AND PARTNERSHIPS.** There will be a forward-looking focus on IFAD throughout the second day, which will include the consideration of business items, the annual Governors' Round Table, Governors' Dialogues and other events that celebrate the power of partnerships.

IFAD fulfils a unique role in rural transformation as an innovative specialized agency of the United Nations and an international financial institution that promotes and invests in rural areas to render them prosperous, equitable and resilient contributors to national growth.

The overarching theme of the Governing Council is "**CATALYSING INVESTMENT AT THE 1<sup>ST</sup> MILE**". Spanning five regions and 92 countries of investment, IFAD focuses on those who are otherwise left behind: marginalized and vulnerable people living in rural areas. What has often been called "the last mile", IFAD considers to be the **first mile**. It is here – in rural areas – that small-scale farmers grow the food that nourishes both their communities and the rest of the world. It is in rural areas that the impact of climate change, of natural disasters and of limited opportunities especially for the young, and the impetus for economic migration are deepest.

Nearly half of the global population live in the rural areas of developing countries, where hunger and poverty are entrenched. These regions are home to over 80 per cent of the world's extreme poor people. They are also home to small-scale farmers who are critical to local food security and nutrition. Seventy per cent of the food consumed in low- and middle-income countries is produced by these small-scale farmers. This makes rural areas the first mile for reducing poverty and inequality, ensuring stability and feeding the world.

The forty-eighth session of the Governing Council meets at a pivotal juncture. It marks the first year of the Thirteenth Replenishment of IFAD's Resources (IFAD13). Over the course of two days, the Governing Council will explore, inter alia, the importance of IFAD's work at the first mile to assemble finance, strengthen and influence pro-poor policies; to leverage partnerships in support of rural livelihoods and prosperity; and to build resilience to the root causes of fragility – including the impact of conflict, climate change and natural disasters.

With only six harvest seasons left until 2030, the time to invest in the first mile is now.

# DAY 1

## HIGH-LEVEL SEGMENT

### OFFICIAL OPENING OF GC48

The session will be formally opened by the Chairperson of the Governing Council, followed by keynote addresses by high-level speakers and the statement of the President of IFAD.

### CENTRE STAGE

#### UNLOCKING THE POTENTIAL OF THE GLOBAL ALLIANCE AGAINST HUNGER AND POVERTY

*Plenary Hall, open to all delegates*

The flagship G20 Global Alliance, under Brazil's presidency, has brought food security and the fight against poverty to the forefront of the development agenda. This event will provide an opportunity to exchange insights, engage in broad and inclusive cross-country dialogue and discuss innovative ideas to build impactful partnerships to address hunger and poverty.

### SPECIAL EVENT

#### G7, G20 AND IFAD IN 2025: REFORMING THE INTERNATIONAL FINANCIAL ARCHITECTURE TO BUILD A FOOD-SECURE FUTURE

*Plenary Hall, open to all delegates*

This session will provide insights into the accomplishments of the G7 and G20 in 2024 and the priorities for 2025. Considering IFAD's central role in agricultural development and building the resilience of vulnerable communities in the world's poorest countries, the event will reflect on the potential of increasing development finance to invest in the rural sector and increase food security.

### LEADERS' DIALOGUES

#### FINANCING FOR DEVELOPMENT

*Plenary Hall, open to all delegates*

In the context of preparations for the Fourth International Conference on Financing for Development (FfD4), this dialogue among high-level speakers will highlight the critical importance of investing in rural food systems to reach the SDGs, showcasing action by IFAD and other leaders in this field.

### LEADERS' DIALOGUES

#### INVESTING IN NUTRITION

*Plenary Hall, open to all delegates*

Bringing together high-level speakers, this dialogue will focus on the central role of investing in nutrition, highlighting the positive impact in fragile contexts, the nutrition-climate-biodiversity nexus and the role of the private sector. The event will be an opportunity to build momentum towards the Nutrition for Growth Summit, which will convene in Paris in March 2025.

#### ANNUAL GOVERNORS' ROUND TABLE

##### DESIGNING AND DELIVERING FOR IMPACT IN AN INCREASINGLY COMPLEX CONTEXT

*Italian Conference Room, open to all Governors/Heads of Delegation*

The Annual Governors' Round Table will explore IFAD's work in a context of growing complexity, the challenges this entails for IFAD's capacity to deliver transformative country programmes, and lessons learned from the IFAD12 programme of work. Climate change and natural disasters, political and social instability, conflict, financial crises and debt distress, forced displacement, and recurrent crises characterize many of the contexts where IFAD works today. Going forward, extreme poverty is increasingly concentrated in areas marked by fragility. Against this backdrop, it is critical to reflect on how IFAD can deliver positive and sustainable impact at scale in line with its mandate, today and in the coming years.

#### GOVERNORS' DIALOGUE ON SOUTH-SOUTH AND TRIANGULAR COOPERATION

*Plenary Hall, open to all delegates*

This event will provide an opportunity to hear from high-level speakers proactively engaged in sharing the experiences of countries' development journeys, highlighting South-South and Triangular Cooperation as a unique programming modality for brokering partnerships and scaling up successful innovations to benefit global, equitable development.

#### CELEBRATION EVENT

##### RBA AWARD OF EXCELLENCE

Governors are invited to celebrate how country-level collaboration among the Rome-based agencies catalyses impact.
