Report on the status of the Thirteenth Replenishment of IFAD's Resources

1. For the information of the Executive Board, the present document contains the following annexes as at 30 September 2025:
Annex I Summary of the status of contributions to IFAD13.
Annex II Status of core contributions, core additional climate contributions, and the grant element of concessional partner loans to IFAD13.
2. As shown in annex I of this report, total pledges as at 30 September 2025, including core contributions, core additional climate contributions (ACCs) and the grant element of concessional partner loans (CPLs) amounted to US\$1.45 billion, corresponding to 77 per cent of the IFAD13 target of US\$1.875 billion. Member States that have not yet pledged and those intending to increase their contribution are urged to communicate their pledges to the Fund as soon as possible.
3. As at 30 September 2025, instruments of contribution deposited amounted to US\$1.11 billion, or 77 per cent of pledges. Member States whose instruments of contribution have not yet been deposited are requested to take the necessary action.
4. As at 30 September 2025, payments received from Member States for IFAD13 amounted to US\$506.07 million corresponding to 35 per cent of pledges.
