INVITATION OF OBSERVERS TO SESSIONS OF THE GOVERNING COUNCIL

1. In accordance with the terms of the Agreement Establishing IFAD and various rules and decisions of the Governing Council and the Executive Board, observers have been invited to past sessions of the Governing Council. The rules and decisions in question, together with a list of observers who may be invited to each session, are set out in documents EB 87/31/R.57 and EB 88/34/R.52 that were reviewed by the Executive Board at its Thirty-First and Thirty-Fourth Sessions in September 1987 and 1988, respectively.

Non-Governmental Organizations

2. At the Thirty-Fourth Session, the Executive Board decided, *inter alia*, to amend the existing criteria for the selection of non-governmental organizations (NGOs) as observers so that they fall into one of the following categories:

- (a) well-established consensual or “umbrella” organizations, with a large and wide-ranging membership;
- (b) “Advocacy NGOs” that make major efforts to introduce IFAD’s objectives and activities to policy-makers and the general public;
- (c) “Operational NGOs” that have already commenced collaboration with IFAD on a number of projects or which have demonstrated a strong interest in beginning such wide-ranging collaboration with IFAD; and
- (d) in the selection of NGOs from the groups specified in sub-paragraphs (a), (b) and (c) above, it shall be ensured that NGOs from the developing countries are adequately represented by consensual NGOs from Africa and Asia, Latin America and the Caribbean, and the Near East and North Africa.



3. In line with these criteria, the Executive Board may wish to increase the number of NGOs that may be invited to attend sessions of the Governing Council. One such additional NGO, Movimondo-Molisv (Movimondo), has applied for observer status with IFAD. Therefore, it is proposed that Movimondo be invited to the Twenty-Third Session of the Governing Council and to all subsequent sessions. Information on the organization is contained in the attached annex.

Palestinian Authority

4. Under the Oslo Accords between the Palestine Liberation Organization and the Government of Israel, the Palestinian Authority is the designated administrative authority for the Gaza Strip and the West Bank. As such, the Palestinian Authority is responsible for the implementation of IFAD-financed projects in the areas under its authority. The Palestinian Authority, which is not eligible for membership but nevertheless receives financing from IFAD, has expressed interest in attending sessions of the Governing Council, some of the decisions of which may affect it.

Recommendation

5. Movimondo and the Palestinian Authority meet the criteria previously established by the Executive Board. Given that the objectives and activities of these organizations aim at increasing the level of the poorest sectors of the populations in, respectively, the less developed countries and their own territory, in conformity with IFAD's objectives, it is proposed that the Executive Board authorize the President to invite Movimondo and the Palestinian Authority as Observers to the Twenty-Third and future Sessions of the Governing Council.

Objectives

Movimondo-Molisv's main objectives are to:

- Promote international solidarity and cooperation towards eliminating poverty and building a world in which everyone has a right to citizenship through cooperation, training, education and the mobilization of resources.

At the field level, Movimondo's main activities include:

- institutional development at the local level;

- environment protection and rehabilitation;
- hydrology and water supply;
- professional training and development of skills for employment;
- small and micro-enterprise development;
- rehabilitation of health services; and
- primary health care.

In relation to advocacy and public awareness campaigns, Movimondo's main target groups are the political, governmental and non-governmental sectors; strategic groups such as educators and the media; and the general public. In Italy in particular, Movimondo undertakes educational and information initiatives designed to contribute to developing a culture of solidarity against every form of racism and discrimination by promoting awareness of problems throughout the world, respect for immigrants and an understanding of the real causes of marginalization and poverty.

Relations with IFAD

Movimondo participated in the last two IFAD/NGO annual consultations and is a member of the IFAD/NGO Advisory Group. Its representative in the Advisory Group addressed the last Governing Council, reporting on the outcome of the Ninth IFAD/NGO Annual Consultation.
