STATUS OF CONTRIBUTIONS TO THE FOURTH REPLENISHMENT OF IFAD'S RESOURCES

ADDENDUM

- 1. Following the issue of document EB 2000/70/R.2, dated 9 August 2000, on the status of contributions to the Fourth Replenishment of IFAD's Resources as at 31 July 2000, an amount of NLG 4 000 000 equivalent to USD 2 313 743 was received from The Netherlands as the third instalment of its complementary contribution to the Fourth Replenishment in support of IFAD's participation in the World Bank/International Monetary Fund Heavily-Indebted Poor Countries (HIPC) Debt Initiative.
- 2. With the receipt of these funds, the cumulative amount received from The Netherlands amounts to USD 6.9 million equivalent, or 45% of the complementary contribution to the Fourth Replenishment. This is reflected in the annex to this document, showing the status of complementary contributions to the Fourth Replenishment as at 8 September 2000.
- 3. Consequently, under complementary contributions to the Fourth Replenishment, payments in cash and promissory notes amounting to USD 28.2 million equivalent have been received, representing 69.4% of total complementary pledges of USD 40.6 million equivalent.
- 4. The status of contributions to the Fourth Replenishment of IFAD's Resources as presented in Annexes I and II of document EB 2000/70/R.2 remained unchanged as at 8 September 2000.
