PLANNED PROJECT ACTIVITIES 2000-2001

GRANTS UNDER THE SPECIAL OPERATIONS FACILITY APPROVED BY THE PRESIDENT

1. At its Third Special Session held on 17 January 1986, the Executive Board authorized the President to provide for preparatory activities directly related to the Fund's lending operations under the Special Programme for Sub-Saharan African Countries Affected by Drought and Desertification, to be undertaken before or after loan effectiveness, by assisting with funding up to the level of USD 600 000 and USD 250 000, respectively, for each proposal.

2. At its Eighteenth Session in January 1995, the Governing Council adopted Resolution 85/XVIII, which extended the authority of the President to approve Special Operations Facility (SOF) grants under the Regular Programme. Such grants would be provided to IFAD borrowers entitled to highly concessional terms and on the basis of strict priority criteria.

3. A description of five grants approved by the President of IFAD under the SOF, designated as Annex D of document EB 2000/71/R.28, is attached.

Africa I	Burkina Faso	Community-Based Rural Development Project (PNGT II)	60 000	To facilitate project effectiveness and early project start-up. Funds will be used to recruit a facilitator to assist the borrower in: (i) fulfilling conditions of loan effectiveness; (ii) preparing the institutional framework for project implementation (in particular in those areas where PNGT II will complement the activities of ongoing IFAD projects); (iii) drawing up the project's first-year annual programme of work and budget (APW/B); (iv) organizing a workshop to launch institutional collaboration between PNGT II and other IFAD-financed projects; and (v) supporting preparations for the baseline survey.
Asia and the Pacific	Cambodia	Community-Based Rural Development in Kampong Thom and Kampot	60 000	To facilitate project start-up and implementation. Proceeds of the grant will be used to: (i) prepare the APW/B and provide training to project staff in this area; (ii) organize a start-up workshop; (iii) establish the monitoring and evaluation system; (iv) provide training in financial management and procurement procedures; (v) translate the appraisal report and implementation manual into Khmer and arrange for their distribution; and (vi) arrange for overseas training and study tours on decentralization.
