**STATUS OF CONTRIBUTIONS TO THE FOURTH REPLENISHMENT OF IFAD'S  
RESOURCES**

2. As of 13 October 2000, instruments of contribution received from Member States amounted to USD 370.4 million equivalent. Collectively, instruments of contribution deposited with the Fund, and payments by Member States against pledges not supported by instruments of contribution, amounted to USD 407.8 million equivalent, or 97.2% of total pledges under the Fourth Replenishment.

3. As of 13 October 2000, payments in cash and promissory notes amounted to USD 367.1 million equivalent, or 87.5% of total pledges of USD 419.6 million.

4. Under the complementary contributions to the Fourth Replenishment, Belgium has increased its pledge by an additional amount of BEF 50 million, and another additional amount of USD 128 500. The amounts in question have been received in cash. This brings the total complementary contribution of Belgium under the Fourth Replenishment to USD 26.9 million equivalent.

5. Consequently, as of 13 October 2000, the aggregate complementary pledges made by the Governments of Belgium and The Netherlands amounted to USD 42.3 million equivalent, against which payments in cash and promissory notes amounting to USD 33.8 million equivalent, or 79.9%, have been received.

6. Members of the Executive Board will recall that, on 29 August 1997, the Fourth Replenishment was declared effective in accordance with Resolution 87/XVIII of the Governing Council on the Fourth Replenishment of IFAD's Resources, when instruments of contribution deposited and payments made against pledges not supported by instruments of contribution to IFAD amounted to USD 216.4 million, or 51.6% of total pledges of USD 419.6 million equivalent.



7. Resolution 87/XVIII also provides Member States with the option of making payments of their contributions in either a single sum or in no more than three instalments. For those Member States that opt to pay in more than one instalment, paragraphs I.8(a)(i) and I.8(a)(ii) of the Resolution provide the following modalities:

Paragraph I.8(a)(i)

“... The single sum or the first instalment shall be due on the thirtieth day after the Member’s instrument of contribution enters into effect, and any other instalment shall be due on the first anniversary of the entry into effect of the Replenishment but the balance, if any, of the payment shall be made no later than a date three years after the completion of this Resolution, except as the Executive Board shall otherwise determine.”

Paragraph I.8(a)(ii)

“Instalment payments in respect of each unqualified contribution shall be, at the option of the Member, either (A) in equal amounts or (B) in progressively graduated amounts with the first instalment amounting to at least thirty percent (30%) of the contribution, the second instalment amounting to at least thirty five percent (35%) and the third instalment, if any, covering the remaining balance. In special circumstances, the Executive Board may, upon the request of a Member, agree to vary the prescribed percentages or number of instalments of a Member subject to the requirement that such a variation shall not affect adversely the operational needs of the Fund.”

8. Members of the Executive Board are kindly requested, therefore, to note the following and to initiate appropriate action as soon as possible:

- Member States that have yet to deposit their instruments of contribution should proceed to do so as soon as possible.
- Member States that have deposited their instruments of contribution should have paid the first and second instalments of their contributions by 29 August 1998, i.e., by the first anniversary of the effectiveness of the Fourth Replenishment, and the third instalment by 20 February 2000, i.e., three years after the completion of Resolution 87/XVIII on the Fourth Replenishment.
