### STATUS OF CONTRIBUTIONS TO THE SIXTH REPLENISHMENT OF IFAD'S RESOURCES

#### THIRD REPORT – ADDENDUM

1. For the information of the Executive Board, the present document contains the following annexes updated to 11 December 2003:

Annex I: Summary of Status of Contributions to the Sixth Replenishment

Annex II: Status of Contributions to the Sixth Replenishment

Annex III: Status of Complementary Contributions to the Sixth Replenishment.

2. The summary table in Annex I shows that total pledges to the Sixth Replenishment, including complementary contributions, amounted to USD 493.7 million equivalent as at 11 December 2003, representing 88.2% of target pledges of USD 560 million equivalent. Collectively, including complementary contributions, Instruments of Contribution deposited with the Fund and payments not supported by Instruments of Contribution amounted to the equivalent of USD 245.5 million or 49.7% of pledges. Total payments received in cash or promissory notes for the Sixth Replenishment amounted to USD 61.4 million equivalent or 12.4% of pledges.

3. Annex II shows the details of Member State contributions to the Sixth Replenishment as at 11 December 2003, excluding complementary contributions. Since the issue of document EB 2003/80/R.10, which showed the status of contributions to the Sixth Replenishment on 31 October 2003, the following developments have taken place:

4. Annex III shows the details of complementary contributions to the Sixth Replenishment. As at 11 December 2003, there has been no change in the status of complementary contributions to the Sixth Replenishment since the issue of document EB 2003/80/R.10.

5. As indicated in paragraph 2 above, pledges have been received for the Sixth Replenishment in an amount equivalent to 88.2% of target pledges of USD 560 million. Member States that have not yet announced their pledge to the Sixth Replenishment of IFAD's Resources are invited to do so as soon as possible.

6. Resolution 130/XXVI of the Governing Council on the Sixth Replenishment of IFAD's Resources stipulates that the replenishment period will commence on 1 January 2004 and end on 31 December 2006. With reference to the date on which Replenishment will come into effect, paragraph 7(a) of the Resolution states:

**“Effectiveness of the Replenishment.** The Replenishment shall come into effect on the date upon which the Instruments of Contribution relating to contributions from all the Members have been deposited with the Fund in the aggregate total amount equivalent to at least fifty per cent (50%) of the total contribution to the Replenishment of all such Members as set forth in Column B-3 of Attachment A to this Resolution.”

7. As mentioned in paragraph 2 above, Instruments of Contribution and payments not supported by Instruments of Contribution had been received in an amount equivalent to 49.7% of pledges as at 11 December 2003. To ensure timely effectiveness of the Sixth Replenishment, those Member States that have not done so are kindly urged to deposit their respective Instruments of Contribution, or pay their contributions to the Sixth Replenishment, as soon as possible.
