DRAFT PROVISIONAL AGENDA AND PROGRAMME OF EVENTS

1. In line with the format introduced in recent years, the proceedings of the Twenty-Seventh Session of the Governing Council will include an interactive panel discussion, which, as shown in the Programme of Events, will be held in the plenary on the first day of the Session. Given the increasing relevance of markets and trade for the rural poor and the opportunities and challenges the new trade environment potentially creates for them, the President has proposed as the theme of this discussion "Trade and Rural Development".

2. On the second day of the Session, six round-table discussions on topics identified in consultation with the regions will be held simultaneously. Each round table will be chaired by a minister or senior representative from the region concerned; IFAD division directors, country programme managers and senior economists will assist the groups and introduce the relevant topic. National delegations are invited to attend the round-table discussions of their choice and, to maximize interaction, may even wish to have different members attend different discussion groups.

1. **Opening of the Session**

The Twenty-Seventh Session of the Governing Council will be held on Wednesday, 18 February and Thursday, 19 February 2004 at the Palazzo dei Congressi, Piazzale J. F. Kennedy, Rome (EUR). The Session will be opened at 10.00 hours on Wednesday, 18 February 2004.

2. Adoption of the Agenda

The Provisional Agenda, prepared by the President and approved by the Executive Board in accordance with Rule 6 of the Rules of Procedure of the Governing Council, is contained in the present document as is information on the programme of events scheduled during the Session.

3. Election of the Bureau of the Governing Council

The Governing Council is invited to elect a chairman and two vice-chairmen for the coming two years, in accordance with Rule 12 of its Rules of Procedure.

4. Statement of the President of IFAD

President Lennart Båge will make a statement to the Governing Council.

5. General Statements

Governors are invited to make general statements under this agenda item, taking into consideration the panel discussion's theme this year, and to comment on other items on the agenda, as appropriate.

6. **Report on the Sixth Replenishment of IFAD's Resources**

Document GC 27/L.2 will provide the latest status of pledges made to the Sixth Replenishment and the status of its effectiveness.

7. Audited Financial Statements of IFAD – 31 December 2002

In accordance with Regulation XII of the Financial Regulations of IFAD and Section 9 of the By-Laws for the Conduct of the Business of IFAD, the Governing Council is invited to consider document GC 27/L.3, which contains the Audited Financial Statements of IFAD for 2002 and the report of the external auditor. The Seventy-Eighth Session of the Executive Board reviewed the statements in April 2003 and recommended that they be submitted for the approval of the Governing Council.

8. Administrative Budget of IFAD and its Office of Evaluation for 2004

The Administrative Budget of IFAD and its Office of Evaluation for 2004, as recommended by the Executive Board for approval, will be presented in document GC 27/L.4, together with a draft resolution thereon.

9. Delegation of Authority to Establish Multi-Donor Trust Funds

A proposal to delegate the Governing Council's authority to establish multi-donor trust funds to the Executive Board, as reviewed and recommended for approval by the Board at its Eightieth Session, will be presented in document GC 27/L.5, together with a draft resolution thereon.

10. Progress Report on the Process Re-Engineering Programme (Strategic Change Programme)

At its Twenty-Third Session, the Governing Council adopted Resolution 116/XXIII approving a Process Re-Engineering Programme, for a five-year period during the financial years 2000-2005. Document GC 27/L.6 will present the annual progress report on the programme (now the Strategic Change Programme).

11. Report on the Lessons Learned by the International Land Coalition

Document GC 27/L.7 will provide a report on the lessons learned by the International Land Coalition on ways and means to improve access by the poor to productive resources, in the countries and regions where the coalition is currently operational.

12. Progress Report on the Global Mechanism of the United Nations Convention to Combat Desertification

The Twenty-First Session of the Governing Council of IFAD approved the selection of IFAD to house the Global Mechanism of the United Nations Convention to Combat Desertification. Document GC 27/L.8 will report on the operations of the Global Mechanism during 2003.

13. **Other Business**

Approval of Disclosure of Documents

The IFAD Policy on the Disclosure of Documents contains a provision that the disclosure of documents for any particular session is the prerogative of the governing body concerned.
