**STATUS OF CONTRIBUTIONS TO THE
SIXTH REPLENISHMENT OF IFAD'S RESOURCES**

FOURTH REPORT – ADDENDUM

1. For the information of the Executive Board, the present document contains the following annexes updated to 15 April 2004:

Annex I: Summary of Status of Contributions to the Sixth Replenishment

Annex II: Status of Contributions to the Sixth Replenishment

Annex III: Status of Complementary Contributions to the Sixth Replenishment.

2. The summary table in Annex I shows that total pledges to the Sixth Replenishment, including complementary contributions, amounted to USD 500.2 million equivalent as at 15 April 2004, representing 89.3% of target pledges of USD 560 million equivalent. Collectively, including complementary contributions, instruments of contribution deposited with the Fund and payments not supported by instruments of contribution amounted to the equivalent of USD 377.1 million or 75.4% of pledges. Total payments received in cash or promissory notes for the Sixth Replenishment amounted to USD 127.1 million equivalent or 25.4% of pledges.

3. Annex II shows the details of Member State contributions to the Sixth Replenishment as at 15 April 2004, excluding complementary contributions. Since the issue of document EB 2004/81/R.4, which showed the status of contributions to the Sixth Replenishment on 24 February 2004, the following developments have taken place:

4. Member States that have not yet done so are urged to deposit their respective instruments of contribution or pay their contributions to the Sixth Replenishment as soon as possible.

5. Annex III shows the details of complementary contributions to the Sixth Replenishment at 15 April 2004. Since the issue of document EB 2004/81/R.4 showing the status of contributions to the Sixth Replenishment at 24 February 2004, further payments of complementary contributions have been received from Canada, as full payment of its pledge of USD 1.3 million equivalent to increase the scope of rural development programming, and from the United Kingdom, in the amount of USD 200 000 towards the IFAD Initiative for Mainstreaming Innovation. Pledges of complementary contributions to the Sixth Replenishment now amount to USD 29.1 million equivalent, of which a total of USD 9.0 million equivalent has been received.

6. Article 3(b) of the General Clause of Resolution 130/XXVI adopting the Sixth Replenishment states:

“The target level of the Replenishment is established at five hundred and sixty million United States dollars (USD 560 000 000)... In seeking that objective, the Replenishment has been accomplished through the good will of all Members in making an effort to ensure the availability of a sufficient level of resources to the Fund. In this respect, the Member Countries shall endeavour to ensure that the target level of the Replenishment is achieved....”

7. As indicated in paragraph 2, pledges for the Sixth Replenishment have been received in an amount equivalent to 89.3% of the Replenishment target. Those Member States that have not yet pledged their contribution to IFAD's Sixth Replenishment are strongly encouraged to do so as soon as possible so that the target level of the Replenishment may be reached.
