## INTERNATIONAL FUND FOR AGRICULTURAL DEVELOPMENT Executive Board – Eighty-Second Session

Rome, 8-9 September 2004

#### RESOURCES AVAILABLE FOR COMMITMENT

- 1. For the information of the Executive Board, Attachments I and II contain details of the resources available for commitment under IFAD's Regular Programme as at 30 June 2004. As per the information in the following paragraphs, no additional Advance Commitment Authority (ACA) is being requested at this session of the Executive Board.
- 2. According to the new practice for ACA, under the Sixth Replenishment resolution "total net flows" will be maintained as resources available for commitment. During the period January to June 2004, the total net flows were estimated to be USD 195.6 million, as shown in Attachment I. Taking into account expected net flows for July and August and the loans and grants presented for approval at this Executive Board session of USD 108.7 million as shown in Attachment IV, net resources available for commitment carried forward would be some USD 143.9 million.
- 3. Details on Member States' contributions specifically excluded from committable resources as at 30 June 2004 are provided in Attachment II.
- 4. Attachment III provides details of loans and grants approved by the Executive Board at its Eighty-First session in April 2004.
- 5. Attachment IV gives information on the loans and grants presented to the current session of the Executive Board, amounting to approximately 74.0 million Special Drawing Rights (SDRs). Based on exchange rates in force as at 30 June 2004, such loans and grants amount to some USD 108.7 million.
- 6. Attachment V shows commitments under the use of the ACA and further analysis of net flows during 2003.
- 7. Attachment VI shows the expected net inflows until 31 December 2004.

#### **Advance Commitment Authority and its Ceiling**

- 8. The Governing Council authorized the use of ACA at its Twentieth Session in February 1997. Its main purpose is to cover shortfalls in the amount of committable resources available to approve loans and grants that may arise in a particular year due to delays in the receipt of contribution payments, volatility in the rate of return of investment income, and/or delays in the receipt of payments and repayments under loans provided by the Fund.
- 9. When the ACA scheme was adopted for the Fourth Replenishment, the maximum amount that could be made available through ACA during that replenishment period was set at USD 450 million. This was equivalent to three years of reflows at the time. The procedures for use of ACA during the Fifth Replenishment period are set out in document GC 24/Res.119/XXIV/Rev.1.
- 10. The procedures for the use of ACA during the Sixth Replenishment period are set out in document GC 26/Resolutions/Rev.1. The ceiling for the use of ACA during the Sixth Replenishment period based on the same principles as that of the Fourth and Fifth Replenishment periods, is namely a ceiling of three years of reflows. On the basis of current estimates of loan reflows for the next three years, this would amount to approximately USD 570 million. However, at the Consultation for the Sixth Replenishment it was also emphasized that efforts should be made to keep actual ACA use below the ceiling. According to the new procedures adopted, "total net flows" will be maintained as resources available for commitment. If necessary, the ACA requested at each Executive Board will then represent the excess of loan and grant commitments over the resources available for commitment. At year end, taking into account net resources available for commitment, the ACA carried forward will be adjusted accordingly. This procedure will make the use of the ACA clearer and more transparent. The additional use of ACA in any given year will be the simple sum of the ACA approved by the Executive Board at its three sessions during the year.
- 11. As may be seen in Attachment V, the level of ACA carried forward as of 31 December 2003 is USD 331.1 million. Net ACA utilization is showing a declining trend, as it was USD 153.7 million in 2001 and USD 124.1 million in 2002 and USD 53.3 million in 2003. As may be seen in Attachment VI, total net flows in January to August 2004 are estimated to be USD 252.6 million, taking into consideration the loan and grant commitments approved to date in 2004. Loans and grants amounting to USD 108.7 million are proposed for the September Executive Board. Therefore no additional ACA is being requested at this session of the Executive Board. An update of this document will be provided to the Eighty-Second Session of the Executive Board only should the net resources position of IFAD deteriorate significantly during the period proceeding the September Executive Board session.
