1. At its eightieth session held on 17-18 December 2003, the Executive Board authorized the President to approve, on behalf of the Board, grants not exceeding the equivalent of USD 200 000 for each proposal, and to report annually to the Executive Board on the use of such authority.
2. A description is attached of 33 grants approved under this arrangement in 2005, up to and including 31 December 2005. The grant criteria and approval process used were those of the IFAD Policy for Grant Financing approved in December 2003 (EB 2003/80/R.5/Rev.1 and EB 2003/80/C.R.P.1).

PA	Support to the Government of Cameroon (Ministry of Agriculture and Rural Development) – Update of Country’s Rural Development Strategy and of its Operational Framework	Ministry of Agriculture of Cameroon	170 000	The purpose of this grant is to assist the Government of Cameroon, in particular the Ministry of Agriculture and Rural Development, in updating its rural sector development strategy and the related operational framework. The strategy reflects the Government’s deep commitment to reducing rural poverty and provides a new perspective for agricultural growth and rural development. In both documents, the Government has set out development goals, policies and strategic orientations and objectives aimed at reducing poverty in rural areas while addressing the specific concerns of the rural poor. The reformulation of the operational framework aims to ensure timely and effective implementation of the country’s poverty reduction strategy. The grant will support the development of a five-year programme of action, a related medium-term financing plan and procedures for implementing, monitoring and evaluating progress.
PF	Building a Knowledge Management Strategy for Effective Rural Development in East Africa	International Support Group	200 000	The programme’s objective is to enable groups of farmers and service providers in East Africa to exchange ideas and experiences on how to improve access to services and markets. To this end, the programme will mentor existing farmer groups in Kenya, the United Republic of Tanzania and Uganda; conduct field visits to learning groups; train new learning groups; develop training resources; prepare and make presentations to senior government and donor staff in the country; regularly convene other institutions involved; and prepare regular briefs on policies for public support emerging from the local experiences.
PF	Conservation Agriculture Practices, Challenges and Lessons	International Institute of Rural Reconstruction	66 000	The programme will consolidate and document innovative practices and lessons learned during the research and dissemination of conservation agriculture (CA) in Africa. It will collaborate with a number of partners to realize its expected objectives and outputs, namely: enhance understanding and knowledge among CA practitioners; produce a table of contents for the CA manual/kit produced during preparatory workshop; create a CA network; gather and document experiences of individuals, communities and organizations along with lessons learned; print and widely disseminate a CA manual; and launch the CA manual during the global CA conference.
PF	Support to Enhance Targeting under Uganda’s Plan for Modernization of Agriculture	Ministry of Agriculture of Uganda	200 000	The overall goal of this grant is to enhance implementation of the Government’s plan for modernization of agriculture (PMA), which is a holistic strategic and policy framework that seeks to reduce poverty through agricultural transformation and thus contribute to the country’s overall framework for poverty reduction. The specific objectives include: (i) developing clear differentiated targeting strategies with a focus on approaches and mechanisms to effectively reach the poor (particularly women) in planning and implementing the PMA’s activities; and (ii) enhancing the capacity of the PMA secretariat and field-level implementing partners to effectively guide, implement and monitor the targeting approaches/mechanisms under PMA pillars and activities.

Each operation has specific targeting to reach women, young people and other vulnerable groups (including HIV/AIDS-affected households). The activities of this grant focus on building capacity at various levels, from village-level self-help groups/organizations to local government. Representation from local groups means that women and other vulnerable groups will have targeted access to participate in the programmes. Each pilot district (Babati, Hai, Mbeya Rural, Mpwapwa, Rombo) has a learning group of 25 members drawn from facilitation teams based in the five wards in which activities are focused. In addition, local government staff will receive training.
PF	Project for Technical Assistance to the United Republic of Tanzania's Rural Financial Services Programme	Mennonite Economic Development Associates	100 000	The project will collaborate with the Government's Rural Financial Services Programme (RFSP), which has selected 100 rural microfinance institutions (MFIs) in three zones (Northern, Southern and Central) in which to target its operations. The project will work with 52 of these MFIs scattered randomly throughout the three zones. Its monitoring activities are expected to provide valuable information to the RFSP coordination office and, in particular, to groups involved in training the MFIs. This information should provide a foundation for stronger rural MFIs with improved financial and managerial performance. This will in turn lead to MFIs' improving their services to the rural community they serve.

This goal will be achieved by enhancing and supporting pro-poor innovations that contribute to sustainable improvements in the livelihoods of poor and disadvantaged people in the uplands of Afghanistan. Another goal is to foster improved policy dialogue in order to develop an enabling environment for sustainable pro-poor development.

Its main objectives are to: build the capacities of existing village-based rural institutions; strengthen sustainable livelihood and income-generating opportunities; develop alternative, sustainable rural financial mechanisms; serve excluded groups; and advocate for a healthy and sustainable development of human and natural resources.

The Microcredit Summit Campaign is helping achieve the Millennium Development Goals (MDGs), especially the goal of halving absolute poverty by 2015.

The proposed grant is consistent with three areas of focus of IFAD's small country grants: (i) improving public policy frameworks; (ii) strengthening institutional frameworks; and (iii) establishing networks for knowledge gathering and dissemination.

PN	Development of an MDG- and Rural Poverty-oriented Monitoring and Evaluation System in the Federal Ministry of Agriculture and Forestry in the Sudan	Ministry of Agriculture and Forestry of Sudan	100 000	The objective of the grant is to develop an effective system for monitoring the performance of the rural and agricultural sector in the Sudan, both the northern and southern regions, drawing lessons from the Performance-based Allocation System and the Results and Impact Management System introduced by IFAD.
PN	Women Traditional Cheese Packaging Centre in Srebrenica Bosnia and Herzegovina	United Nations Development Programme	200 000	The objective of the grant is to join other United Nations agencies involved in the Srebrenica Regional Recovery Programme in providing poverty reduction support to the people of Srebrenica, an area of Bosnia and Herzegovina that suffered severely during the war of 1992-1995. The grant specifically seeks to improve women's technical, managerial and financial skills related to the production, processing and marketing of traditional cheeses in order to boost their income-earning potential.

The programme will develop ways of establishing links with ongoing loan projects and with new projects as a means of adaptive replication in other countries. In addition, it will document technology and enterprise options; prepare enterprise training courses; document bamboo enterprise market linkage systems; and input technical and financial information into IFAD's electronic knowledge networking systems in Asia and the Pacific (ENRAP), Latin America and the Caribbean (FIDAMERICA) and Africa (FIDAFRIQUE).

Operationally, the long-term programme goal is to enable rural people to adapt to climatic and related environmental changes through better management of land and water resources. To attain these goals, the programme will engage national and international policy-makers, international research entities, national agricultural research systems, land and water management programmes, network partners and other regional stakeholders. The programme's focus will be to demonstrate the viability and feasibility of the green water concept.

Its specific objectives are to: establish a pilot, community-led alliance against hunger; develop the capacity of civil society and local faith-based organizations; and establish a broad framework for starting advocacy on a state poverty reduction campaign.

The intent is that this will contribute to: (i) reducing extreme hunger and poverty; (ii) promoting gender equality and empowering women; (iii) ensuring environmental sustainability; (iv) developing global partnerships for development to reach these ends; and (v) promoting an integrated approach to rural development. These goals will be accomplished through experience-sharing on agrarian reform, building on a range of best practices and consolidating information on agrarian reform and rural development.
