REPORT ON THE SEVENTH REPLENISHMENT OF IFAD'S RESOURCES

1. **Adoption.** Resolution 141/XXIX on the Seventh Replenishment of IFAD's Resources was adopted by the Governing Council on 16 February 2006. The period of the Seventh Replenishment is defined in the resolution as "the three-year period commencing 1 January 2007 and ending on 31 December 2009".
2. **Additional pledges.** Pledges made as at the date of adoption of the resolution, i.e. 16 February 2006, amounted to US\$471,612,364, including complementary contributions. Paragraph II.4(b) of the resolution specified a period of six months from the date of adoption of the resolution (i.e. until 16 August 2006) during which pledged contributions would count towards the creation of new votes. As at 16 August, pledges amounted to US\$612,526,599, including complementary contributions. The status of pledges to the Seventh Replenishment as at 16 August 2006 is set out in annex I.
3. **Target.** Paragraph II.3(b) of Resolution 141/XXIX established the target level of the Seventh Replenishment at US\$800 million. By decision of the Governing Council at its twenty-ninth session, authority was given to the President of IFAD to adjust the target level on the basis of pledges received as at 16 August 2006, so that the total amount of the pledges received as of that date represents 85 per cent of the adjusted target. As indicated in paragraph 2, above, and as set forth in annex I, pledges made as at 16 August amounted to US\$612,526,599, including complementary contributions. Accordingly, the President of IFAD, by virtue of the authority conferred on him by the Governing Council, adjusted the target level to US\$720 million. Paragraph II.3(b) of Resolution 141/XXIX has been amended accordingly, and the figures in paragraphs II.4(b) and IV.19 and Attachments A and C have been updated (as at 16 August 2006).
4. **Creation of new votes.** Under the voting system introduced on 20 February 1997 by Resolutions 86/XVIII and 87/XVIII, new votes are created for each replenishment. These votes are allocated on a basis similar to the original and replenishment votes and are divided between membership and contribution votes. As Resolution 141/XXIX provided that votes for the Seventh Replenishment would be calculated on the basis of aggregate pledges received within the six months following the resolution's adoption on 16 February 2006, i.e. by 16 August 2006, paragraph IV.19 of the resolution could not be completed at the time of the resolution's adoption.
5. Of the total pledges of US\$612,526,599 received as at 16 August, pledges amounting to US\$25,983,391 were in the form of complementary contributions, pledged in accordance with paragraph II.4(d) of Resolution 141/XXIX, and thus do not count towards the creation of votes. This results in a balance of US\$586,543,208 for the creation of Seventh Replenishment votes.
6. Under the formula stipulated in Article 6, Section 3(a)(ii), of the Agreement Establishing IFAD, 100 replenishment votes are created for every US\$158 million of convertible currency contributions pledged. Thus, for the Seventh Replenishment, the amount of US\$586,543,208 creates 371.23 replenishment votes, which are broken down into membership votes and contribution votes. The total of the Seventh Replenishment votes is fixed and will not be altered by any change in the membership of the Fund or further pledges to the Seventh Replenishment.
7. Paragraph IV.19 of Resolution 141/XXIX has been completed as follows (the text added is underlined), as contained in revised Resolution 141/XXIX:

"Allocation of New Votes for the Replenishment

In accordance with Section 3(a)(ii) of Article 6 of the Agreement, three hundred and seventy-one point two three zero (371.230) new votes are hereby created

for the Replenishment (“Seventh Replenishment Votes”). Those votes shall be distributed as follows:

- (a) **Membership Votes.** One hundred and fifty-seven point zero five nine (157.059) votes shall be allocated as membership votes, with each Member receiving an equal number of the said votes. Upon any change in the number of Members of the Fund, the one hundred and fifty-seven point zero five nine (157.059) votes shall be redistributed upon the same basis. Column D-1 of Attachment C to this Resolution, as it may be amended from time to time, specifies the current distribution of Seventh Replenishment Membership Votes.
- (b) **Contribution Votes.** The remaining two hundred and fourteen point one seven one (214.171) votes shall be allocated as contribution votes to each Member in the proportion that each Member’s paid contribution, valued in USD at the effective rate for the Replenishment, to the additional contributions made under the Replenishment, as specified in paragraph II.4(a) of this Resolution and as amended by paragraph II.4(b) of this Resolution, bears to the aggregate of the total contributions made by all Members to the Replenishment. For that purpose, a paid contribution shall be deemed to be only the part of a contribution of a Member actually paid to the Fund, in accordance with paragraph IV.20 of this Resolution. Column D-2 of Attachment C to this Resolution, as it may be amended from time to time, specifies the potential Seventh Replenishment Contribution Votes for each Member if all Members pay the pledges specified in Column B-2 of Attachment A to this Resolution. Column D-3 of Attachment C to this Resolution, as it may be amended from time to time, specifies the actual Seventh Replenishment Contribution Votes of each Member.
- (c) **Effectiveness.** The allocation of the three hundred and seventy-one point two three zero (371.230) votes, as specified in provisions (a) and (b) above, shall enter into effect upon the date on which the period specified in paragraph II.4(b) of this Resolution shall come to an end.”

8. Accordingly, the membership and contribution votes became effective as from 17 August 2006. A completed version of Attachment C to Resolution 141/XXIX containing the calculation of membership and contribution votes, including Seventh Replenishment votes, is attached hereto as annex II. Although the number of Seventh Replenishment votes is fixed at a total of 371.23, the distribution of contribution votes among Member States will change as payments of contributions are received. Therefore, all Member States contributing to the Seventh Replenishment, including those announcing their pledges after 16 August 2006, will receive a share of the Seventh Replenishment contribution votes in proportion to their respective share of paid-in contributions to the replenishment.

9. **Status of contributions.** Annexes III and IV set out the updated status as at 6 September 2006 of pledges made, instruments of contribution deposited and payments made in cash and promissory notes for the Seventh Replenishment.

10. As at 6 September, pledges to the Seventh Replenishment amounted to US\$612,973,900 equivalent. Member States that have not yet communicated their pledge and those intending to increase their contribution are urged to communicate their pledges to the Fund as soon as possible.

11. In accordance with paragraph II.7(a) of Resolution 141/XXIX, the Seventh Replenishment will become effective on the date “upon which the Instruments of Contribution relating to contributions

from all the Members have been deposited with the Fund in the aggregate total amount equivalent to at least fifty per cent (50%) of the total contribution to the Replenishment of all such Members". The payment of a contribution without the deposit of an instrument of contribution is deemed as equivalent to the deposit of an instrument of contribution for the amount paid. As at 6 September, instruments of contribution and payments equal to 20 per cent of the total pledges of US\$612,526,599 to the Seventh Replenishment had been deposited. Member States are urged to deposit instruments of contribution relating to their pledges as soon as possible in order to attain 50 per cent of the total pledges so that the replenishment may become effective.

12. As at 6 September, advance payments for the Seventh Replenishment had been received from Member States in an amount totalling US\$22.5 million equivalent, or 4 per cent of pledges. Member States are encouraged to make advance payments of their contributions in accordance with paragraph II.8 of the resolution, or to pay their contributions as early as possible within the replenishment period.
