## **Report on the status of contributions to the Seventh Replenishment of IFAD's resources**

1. For the information of the Executive Board, the present document contains the following annexes:

2. As shown in the summary table in annex I, total pledges to the Seventh Replenishment, including complementary contributions, amounted to US\$616.1 million equivalent as at 22 February 2007, representing 86 per cent of the replenishment target of US\$720 million equivalent.
3. Member States which have not yet announced their contribution for the Seventh Replenishment, and those intending to increase their pledge, are urged to contact the Fund in this connection as soon as possible.
4. The table in annex I also shows that collectively, including complementary contributions, at 22 February 2007 instruments of contribution deposited with the Fund and payments not supported by instruments of contribution amounted to the equivalent of US\$357.3 million equivalent or 58 per cent of pledges. The Seventh Replenishment became effective on 22 December 2006, when the aggregate amount of instruments of contribution deposited and payments not supported by instruments of contribution exceeded 50 per cent of total pledges.
5. Member States whose instruments of contribution for the Seventh Replenishment have not yet been deposited are urged to take the necessary measures as soon as possible.
6. At 22 February 2007, total payments received in cash or promissory notes for the Seventh Replenishment amounted to US\$145.6 million equivalent or 24 per cent of pledges.
7. Annex II shows the details of Member States' contributions to the Seventh Replenishment as at 22 February 2007.

The Governing Council has decided that this complementary contribution will be used for the objectives of the Belgian Survival Fund and in conformity with its procedures.

<sup>e</sup> This pledge is subject to a satisfactory agreement on the application of the performance-based allocation system.

<sup>f</sup> The pledge originally recorded in Resolution 141/XXIX was based on a 4.25 per cent share of the replenishment target and subject to government approval. The Canadian Government has since confirmed that its contribution will represent 4.25 per cent of the US\$720 million target, i.e. US\$30.6 million, and an instrument of contribution in this amount has been deposited.

<sup>g</sup> Iraq has pledged US\$2 million plus a 10 per cent increase each year during the Seventh Replenishment period (2007-2009).

<sup>h</sup> In addition to its EUR 6 million pledge for the Seventh Replenishment, Ireland has made an additional voluntary contribution of EUR 891,206 (US\$1,094,176 equivalent).

<sup>i</sup> Kuwait's pledge is subject to approval by the Government.

<sup>j</sup> Pakistan may increase its pledge by a further US\$5 million.

<sup>k</sup> This amount includes SEK 51,770,000 (US\$6,830,536 equivalent) as a complementary contribution in accordance with paragraphs 4(d) and 5(b) of Resolution 141/XXIX, towards the IFAD Trust Fund for the Heavily Indebted Poor Countries Debt Initiative.

<sup>l</sup> Of the United Kingdom's pledge of US\$50 million equivalent, US\$15 million will be contingent upon achievement by 31 December 2007 of certain deliverables that are included in the Action Plan, in accordance with paragraph 5(c) of Resolution 141/XXIX; such deliverables will be communicated by the United Kingdom to the Fund.
