Addendum

- 1. For the information of the Executive Board, and as stated in document EB 2007/92/R.19, Management has prepared an update of the estimated resources available for commitment under IFAD's Regular Programme. The aforementioned document had estimated an additional advance commitment authority (ACA) requirement of US\$119.6 million. As a result of increases in the estimated net inflows of US\$10.0 million, offset by an increase of US\$9.5 million in the final amount of loans and grants presented for approval at this session of the Board, the ACA now being requested at this session is US\$119.1 million. It should be noted that, as expected, two loans originally proposed for approval at this session have been postponed until the April session (Costa Rica and the Philippines).
- 2. Attachment II shows estimated total net resource inflows from 1 January to 31 December 2007 of US\$456.6 million. Loan and grant commitments proposed to the current session of the Board total US\$265.2 million. Taking into account these net flows and commitments, as well as loans and grants already approved of US\$334.2 million and ACA already approved at the April session of US\$23.7 million, additional ACA of US\$119.1 million is required.

Recommendation

3. The Executive Board, in accordance with paragraph III.17 of Governing Council Resolution 141/XXIX/Rev.1, is therefore invited to note the present shortfall in resources in the period of an estimated US\$119.1 million due to estimated net inflows for the year to 31 December 2007 amounting to US\$456.6 million, the loans and grants presented for approval amounting to US\$265.8 million, the loans and grants already approved of US\$334.2 million, and ACA already approved at the April session of US\$23.7 million. As a result, additional ACA of US\$119.1 million is now being requested.
