Planned project activities 2008-2009

- 1. At the second session of the Executive Board, it was agreed that information on planned project activities would be presented to the Board regularly to enable members to keep abreast of developments in IFAD's project/programme pipeline and prospective lending and, should they so desire, to comment on planned operations at an appropriate stage of the development cycle.
- To this end, part I of this document provides a comprehensive listing, by stage of processing and by region, of all projects and programmes that have entered the pipeline after approval of the concept note. In addition, as agreed with the Executive Board in September 2003, IFAD has made available on its website - at http://www.ifad.org/operations/pipeline/index.htm - information on projects and programmes that have reached an advanced stage of design and are thus likely to be presented at a future session of the Board. Each of these operations is described in a two-page information note, which is updated upon completion of each major step in the project cycle. Following discussions with Board members regarding the desirability to receive comments on new planned interventions well in advance, information is being provided about future key country meetings to facilitate incountry discussion/consultation. An interim report was posted on IFAD's public website to provide preliminary information of meetings scheduled in July, August and September 2008. These have been updated, where necessary, in the current report. Additional information about future country meetings and project/programme-related documentation can be provided by the primary IFAD contact given in this document.
- 3. In September 2006, the Executive Board approved a new framework for a results-based country strategic opportunities programme as provided in document EB 2006/88/R.4. Part II of this document provides information on planned country strategic opportunities programmes and subregional strategic opportunities programmes (COSOPs/SRESOPs) and where available identifies dates of forthcoming country meetings and/or stakeholder consultation meetings
- 4. As agreed at the April 2001 Board session (document EB 2001/72/R.28), part III of this document provides information on all country strategic opportunities papers/programmes (COSOPs) and subregional strategic opportunities papers/programmes (SRESOPs) reviewed to date by the Operational Strategy and Policy Guidance Committee (OSC) and those reviewed by the Board.
- 5. The current session of the Board will review three country strategic opportunities programmes (Brazil, Burundi and Viet Nam).
