Proposed dates for sessions of the Executive Board in 2010

- 1. Since the sixty-sixth session (June 1975) of the Food and Agriculture Organization of the United Nations (FAO) Council, a schedule of governing bodies' sessions for the following biennium has been submitted for review and approval at each session of the Council. In an endeavour to harmonize the sessions of their respective governing bodies requiring the participation of permanent representatives in Rome, the Secretariats of FAO, IFAD and the World Food Programme (WFP) prepare a joint calendar of their main sessions.
- 2. Given that the FAO reform process currently under discussion includes the timing of that organization's governing bodies sessions, FAO was not in a position to present a calendar of meetings for 2010.
- 3. In light of the foregoing, and based on past practice at IFAD, the following dates are proposed for the Executive Board sessions to be held in 2010:

• Ninety-ninth Session Wednesday, 14 and Thursday, 15 April 2010

• 100th Session Wednesday, 15 and Thursday, 16 September 2010

• 101st Session Wednesday, 15 and Thursday, 16 December 2010

4. An updated version of this document including the final calendar for all three Romebased agencies will be prepared for the April session of the Executive Board.

5. The Executive Board is requested to approve the dates for its sessions in 2010 as proposed above.
