
Planned project activities 2009-2010

- 1. At the second session of the Executive Board, it was agreed that information on planned project activities would be presented to the Board regularly to enable Members to keep abreast of developments in IFAD's project/programme pipeline and prospective lending and, should they so desire, to comment on planned operations at an appropriate stage of the development cycle.
- To this end, part I of this document provides a comprehensive listing, by stage of processing and by region, of all projects and programmes that have entered the pipeline as part of the results-based country strategic opportunities programmes or after approval of the concept note. In addition, as agreed with the Executive Board in September 2003, IFAD has made available on its website — at http://www.ifad.org/operations/pipeline/index.htm — information on projects and programmes that have reached an advanced stage of design and are thus likely to be presented at a future session of the Board. Each of these operations is described in a two-page information note, which is updated upon completion of each major step in the project cycle. To facilitate processing of the two-page information notes these will now be made available in English only and the language of the country concerned. Following discussions with Board members regarding the desirability of receiving information on new planned interventions well in advance, dates for future key country meetings are being provided to facilitate in-country discussion/consultation. Additional details about future country meetings and project- and programme-related documentation are available on request from the primary IFAD contact given in this document. Supplementary loans/grants, which are part of approved, ongoing projects, to be considered by the Board during the September and December 2009 Board sessions are not reflected in the Planned Project Activities document.
- 3. In September 2006, the Executive Board approved a new framework for a results-based country strategic opportunities programme (COSOP), as provided in document EB 2006/88/R.4. The results-based COSOPs will also serve as the vehicle for entry of projects/programmes into IFAD's official pipeline. Some of these pipeline projects/programmes will be processed within the current 2007-2009 cycle of the performance-based allocation system (PBAS), while others will be included in subsequent PBAS allocation periods. Part II provides information on planned COSOPs and subregional strategic opportunities programmes (SRESOPs) and, where available, identifies dates of forthcoming country meetings and stakeholder consultation meetings.
- 4. As agreed at the Board session in April 2001 (document EB 2001/72/R.28), part III of this document provides information on all COSOPs and SRESOPs reviewed to date by the Operational Strategy and Policy Guidance Committee (OSC) as well as those reviewed by the Board.
- 5. The current session of the Board will review three COSOPs (Chad, Peru and the Philippines).

Overview

6. The current document includes the 75 projects/programmes in IFAD's official pipeline. Efforts to build up the pipeline will continue throughout 2009, particularly for sub-Saharan Africa. This will be achieved in the context of forthcoming results-based COSOPs and concept notes to be reviewed in 2009. This is necessary not only to boost support for agriculture and rural development but also to ensure that sufficient projects/programmes are ready in the event of slippages or in case additional project/programme design work is required prior to Board presentation.

- 7. The projects/programmes included in IFAD's pipeline are selected on the basis of existing COSOPs¹ and governments' poverty reduction strategy papers or national development plans. Where necessary, concept notes are prepared and submitted to the OSC for review/approval prior to entry into IFAD's official pipeline.
- 8. The IFAD Strategic Framework 2007-2010 will continue to guide IFAD's work into the Eighth Replenishment period. A new strategic framework will be delivered to the Executive Board in December 2010 to steer IFAD's activities from 2011 onwards. The chart below shows the 2009 planned share of investments against the various strategic objectives of IFAD's Strategic Framework 2007-2010 (as of 20 July 2009).²



- 9. Some examples of how IFAD is responding to the current food price crisis in the context of overall food security and rural poverty alleviation are given below.
- 10. In Western and Central Africa, for instance, the Agriculture Sector Rehabilitation Project for Liberia, which is planned for presentation to the December 2009 Board, will address post-conflict poverty and food insecurity but at the same time lay the basis for long-term rehabilitation and participatory development. Rice Liberia currently imports 50 per cent of its domestic needs for rice and cassava have been identified as priority crops that could bring "quick wins" in improving household food security. The anticipated outputs of the project are restored and improved agricultural productive capacity, together with increased household food security. In The Gambia, the proposed Livestock and Horticulture Development Project planned for presentation to the December 2009 Board, aims at raising incomes and improving food security with a view to reducing poverty. By supporting horticultural and livestock products and by-products, the project will contribute to replacing increasingly expensive food imports with local products produced in rural areas predominantly by women and to enhancing food security.

¹ Countries with minimal PBAS allocations and countries in which a small-scale country programme is envisaged do not require a COSOP. In such cases, the information that would normally be included in a COSOP is incorporated into the relevant sections of any project/programme design document that is drafted (document EB 2006/88/R.4).

- 11. In Eastern and Southern Africa, the goal of the national Agricultural and Pilot Fishery Programme in **Eritrea**, planned for presentation to the April 2010 Board, is to enhance food security and alleviate rural poverty. The proposed programme will address food security problems across agroecological regions through a major scaling up of earlier lessons learned on intensifying agropastoral systems. The above will foster long-term development of smallholder agriculture, which is the key to food security and rural poverty alleviation in Eritrea. A pilot fisheries initiative will be undertaken in view of the importance of fisheries in food security in the Northern and Southern Red Sea Zobas, a semi-arid region.
- 12. In Asia and the Pacific, the goal of the Crop Maximization Support Project in **Pakistan** (planned for presentation to the September 2009 Board) is to contribute rapidly to food security and poverty reduction by enhancing the productivity of smallholder farmers and rural families in the context of recent dramatic increases in food prices. By doing so, it will support the implementation of the Government of Pakistan's national Crop Maximization Project, which aims to increase productivity and food security.
- 13. In Latin America and the Caribbean, the overall goal of the Value Chain Development Project in **Haiti** is to reduce rural poverty significantly in the area of intervention. It aims to improve the participation of poor households in the economy and to increase the value added created by their productive and economic activities. Given the extent of post-harvest loss of agricultural produce in Haiti, due to inadequate storing, transport and transformation capacities, the project is expected to increase both the availability of food on the national market and the income of small-scale producers.
- 14. In Near East and North Africa, the proposed Rural Access Project in **The Sudan** is expected to contribute towards the goal of empowering the rural poor in such a way that they are able to increase their food security, incomes and resilience to shocks. It is aligned with the strategy of the Government's Agricultural Revival Programme, which emphasizes rural infrastructure, particularly rural feeder roads, as an investment of primary importance to agricultural transformation. Investments in rural roads that facilitate market access by the rural poor constitute an effective strategy to reduce rural poverty, by decreasing transport and transaction costs in the movement of agricultural products and increasing trade and job opportunities.
- 15. In addition to supporting long-term investment in smallholder agriculture and increasing emphasis on agricultural productivity for improved food security and poverty reduction, IFAD's future initiatives will also contribute to combating natural resource degradation and the effects of climate change; supporting other donors in increasing the financing to agriculture and rural development; sharing knowledge and experience; strengthening the focus on land issues; leveraging international remittances; and working with organizations of rural producers.
- 16. As shown in part II, IFAD is contemplating submitting another eight results-based COSOPs to the Board, in the context of the 2009 programme of work. Three were already submitted to the April 2009 Board: Haiti, Pakistan and The Sudan.
