Planned project activities 2009-2010

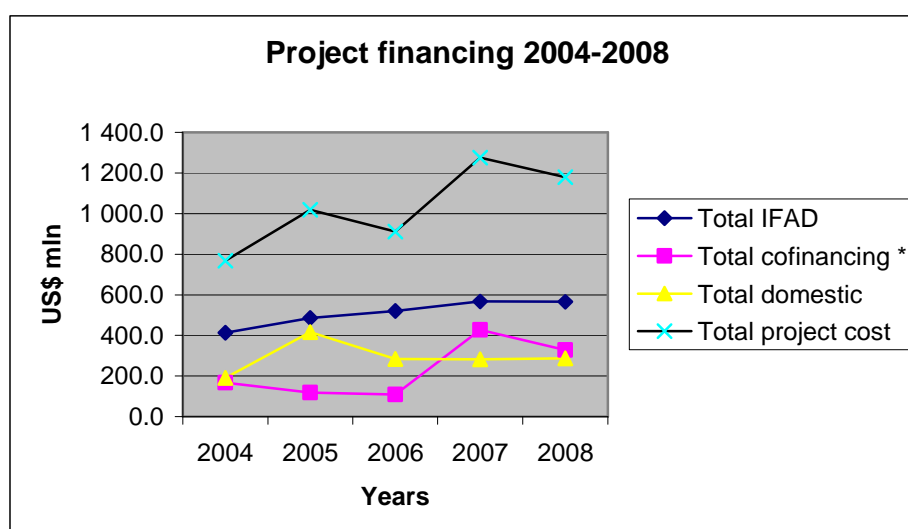
1. At the second session of the Executive Board, it was agreed that information on planned project activities would be presented to the Board regularly to enable members to keep abreast of developments in IFAD's project/programme pipeline and prospective lending and, should they so desire, to comment on planned operations at an appropriate stage of the development cycle.
2. To this end, part I of this document provides a comprehensive listing, by stage of processing and by region, of all projects and programmes that have entered the pipeline as part of the results-based country strategic opportunities programmes or after approval of the concept note. In addition, as agreed with the Executive Board in September 2003, IFAD has made available on its website – at <http://www.ifad.org/operations/pipeline/index.htm> – information on projects and programmes that have reached an advanced stage of design and are thus likely to be presented at a future session of the Board. Each of these operations is described in a two-page information note, which is updated upon completion of each major step in the project cycle. As communicated to the Board at the ninety-seventh session, these two-page information notes will now be made available only in English and the language of the country concerned. Following discussions with Board members regarding the desirability of receiving information on new planned interventions well in advance, dates for future key country meetings are being provided to facilitate in-country discussion/consultation. Additional details of future country meetings and project- and programme-related documentation are available on request from the primary IFAD contact given in this document. Supplementary loans/grants that are part of approved, ongoing projects and are to be considered by the Board during the December 2009 Board session are not reflected in the Planned Project Activities document.
3. In September 2006, the Executive Board approved a new framework for a results-based country strategic opportunities programme (COSOP), as provided in document EB 2006/88/R.4. The results-based COSOPs will also serve as the vehicle for entry of projects/programmes into IFAD's official pipeline. Some of these pipeline projects/programmes will be processed within the current 2007-2009 cycle of the performance-based allocation system (PBAS), while others will be included in subsequent PBAS allocation periods. Part II provides information on planned COSOPs and subregional strategic opportunities programmes (SRESOPs) and, where available, identifies dates of forthcoming country meetings and stakeholder consultation meetings.
4. As agreed at the Board session in April 2001 (document EB 2001/72/R.28), part III of this document provides information on all COSOPs and SRESOPs reviewed to date by the Operational Strategy and Policy Guidance Committee (OSC) as well as those reviewed by the Board.
5. The current session of the Board will review three COSOPs: the Congo, Malawi and the Syrian Arab Republic.

Overview

6. The projects/programmes included in IFAD's pipeline are selected on the basis of existing COSOPs¹ and governments' poverty reduction strategy papers or national development plans. Where necessary, concept notes are prepared and submitted to the OSC for review/approval prior to entry into IFAD's official pipeline.

¹ Countries with minimal PBAS allocations and countries in which a small-scale country programme is envisaged do not require a COSOP. In such cases, the information that would normally be included in a COSOP is incorporated into the relevant sections of any project/programme design document that is drafted (document EB 2006/88/R.4).

7. The current document includes 65 projects/programmes in IFAD's official pipeline. A large number of projects are expected to enter the pipeline in the last quarter of 2009 through concept notes, particularly in Sub-Saharan Africa. Of the 65 projects/programmes, 57 (or 88 per cent) have been initiated by IFAD and 8 (or 12 per cent) have been selected from the pipeline of cooperating institutions (e.g. the African Development Bank, the Asian Development Bank and the World Bank).
8. In terms of distribution by regional divisions, 10 projects/programmes relate to the Western and Central Africa Division; 13 to the Eastern and Southern Africa Division; 18 to the Asia and the Pacific Division; 10 to the Latin America and the Caribbean Division; and 14 to the Near East and North Africa Division. Of the overall total of 65 projects/programmes, 25 are for sub-Saharan African countries
9. Cofinancing is sought, either through IFAD-initiated projects or projects initiated by cooperating institutions, to accelerate the rate of investment in agriculture and help poor rural people to increase their agricultural productivity and incomes. In selecting projects from the pipeline of cooperating institutions, IFAD ensures that they are in line with IFAD's mandate and the IFAD Strategic Framework 2007-2010. As shown in the chart below cofinancing levels in 2007 and 2008² were encouraging; IFAD expects to achieve a similar level in 2009.

10. As shown in part II, so far in 2009 IFAD has submitted nine COSOPs to the Board: the Congo, Chad, Haiti, Malawi, Pakistan, Peru, the Philippines, the Syrian Arab Republic and The Sudan. The planned COSOP for Nigeria had to be deferred pending the Government validation of the draft COSOP. The planned COSOP for Senegal will now be presented to the April 2010 Board.
