- 3. Preview of the Results-based Work Programme and Budget for 2019 and Indicative Plan for 2020-2021 of the Independent Office of Evaluation of IFAD

Document EC 2018/102/W.P.2 contains a Preview of the Results-based Work Programme and Budget for 2019 and Indicative Plan for 2020-2021 of the Independent Office of Evaluation of IFAD (IOE) for consideration by the Committee.
