comprising staff of IOE, PMD and SKD established with a mandate to shape the policy, and supervise and guide the (2) lead consultants







Process underpinning the revision

The revised policy is based on:



- Review of related international standards and practices in IFIs and UN development system
- Consultations with IFAD stakeholders and external experts -IFAD managers, IOE staff (including former Director), members of EC and EB, selected members of ECG
- 3. Feedback from OMC and EMC of IFAD on the previous draft
- Feedback from two expert peer reviewers also sought










Theory of Change





- Credible assessment and impartial evidence used by IFAD'S Executive Board and other Governing bodies to take decisions
- Robust evidence and analysis demanded and used by Management and the Board to improve performance.
- Strong organizational leadership and feedback mechanisms to promote learning
- Evaluation findings disseminated amongst stakeholders
- Stakeholders adequately involved in evaluations
- Clear responsibilities allocated to ensure IFAD-wide learning from all evaluations
- Evaluation Policy provides an institutional framework
- Harmonized evaluation approach and products
- Self and independent Evaluations credible and timely
- Resources & skills for planning, producing, and using
- International evaluation standards adopted
- QA mechanisms and peer review based on DEF
- Advance planning to ensure adequate coverage and to maximize strategic evaluation selection





Evaluation System in IFAD

Independent evaluation

Conducted by IOE structurally, functionally, and behaviorally independent from those responsible for the design and implementation of the intervention

Selfevaluation

Conducted by operational units under the aegis of IFAD Management. Provides robust measurement of results for accountability, corporate impact and the basis for operational performance management, learning and knowledge sharing
