1. **Opening of the session**

The fifty-second session of the Evaluation Committee will be held on Friday, 5 September 2008 at IFAD's headquarters on Via Paolo di Dono 44, Rome. The session will be opened in the Oval Room (S-120) at 9 a.m. and will end at 5 p.m.

2. Adoption of the agenda

The provisional agenda is contained in the present document (EC 2008/52/W.P.1).

3. Country programme evaluation of Pakistan

Document EC 2008/52/W.P.2 contains the executive summary of the country programme evaluation of Pakistan. The full evaluation report is available upon request from the Office of Evaluation (OE).

4. **Monitoring the effectiveness and quality of work of the Office of Evaluation**Paragraphs 30-37 of document EC 2008/52/W.P.3 provide an overview of the proposed approach to monitoring OE's effectiveness and quality of work. To introduce this agenda item and stimulate discussions, OE will give a PowerPoint presentation and share information on the topic obtained from other international financial institutions and United Nations agencies.
