Proposed provisional agenda of the Evaluation Committee for 2011

- 1. **Background.** As per the Terms of Reference and Rules of Procedure of the Evaluation Committee¹ approved by the Executive Board in December 2004, this document contains the proposed provisional programme of work (hereafter "provisional agenda") for the Evaluation Committee in 2011.
- 2. It is to be noted that rule 2 of the Committee's rules of procedure provides that "the Committee retains the prerogative to revise by adding, deleting, defining or amending items on the agenda during the course of the year".
- 3. **Dates of Evaluation Committee sessions.** The document also proposes dates for the five Committee sessions planned for 2011. The dates have been defined in consultation with the Office of the Secretary in order to avoid overlap with the planned governing body meetings of the two other Rome-based United Nations food and agriculture organizations.
- 4. **Objective.** The proposed provisional agenda ensures that the Committee has, as in the past, the opportunity to review and comment on the main evaluation reports produced by the Office of Evaluation (IOE) and IFAD Management. These reports fall into four categories:
 - (a) Evaluation reports produced annually by IOE and Management, as called for by the Committee's terms of reference and rules of procedure. This category includes the Annual Report on Results and Impact of IFAD Operations (ARRI), the Work Programme and Budget of IOE, the Report on IFAD's Development Effectiveness (RIDE), and the President's Report on the Implementation Status of Evaluation Recommendations and Management Actions (PRISMA);
 - (b) A variety of evaluation reports prepared by IOE, including all corporate-level evaluations and a selected number of country programme and project evaluations. A description of the types of evaluations undertaken by IOE is provided in annex I;
 - (c) All corporate operational policy and strategy proposals arising from evaluation lessons and recommendations, including IOE's comments on the proposals before they are considered by the Executive Board;
 - (d) Progress reports on the Action Plan for the Implementation of the Findings and Recommendations of the Peer Review of IFAD's Evaluation System, as decided by the Evaluation Committee at its sixty-third session, as well as the two main deliverables to be produced in this context, namely the revised IFAD Evaluation Policy and the Evaluation Committee's new terms of reference and rules of procedure.
- 5. Criteria for the selection of evaluations to be presented to the Evaluation Committee. IOE reviewed past Committee agenda, particularly those of 2009 and 2010, and found that each year the Committee considered all corporate-level evaluations prepared by IOE, two country programme evaluations, and two or three project evaluations produced by IOE. These figures have been taken into account in preparing this provisional agenda. With regard to country programme and project evaluations, the agenda proposes both those to be completed in 2010 and some to be completed in 2011.
- 6. **Decision.** The Committee is requested to consider the information contained in the following table, and decide on the proposed dates and agenda for its five planned sessions in 2011.

<u>Note</u>: As per the Evaluation Committee's request, the IFAD management and IOE will make a proposal for the Committee's consideration at its session on 25 February 2011 in relation to their annual country visits for the period 2011-2013.

Types of evaluations undertaken by IOE

Corporate-level evaluations are intended to assess the effectiveness and impact of IFAD policies, strategies and approaches related to rural poverty alleviation. Insights and recommendations then feed into the formulation of new and more effective corporate policies and strategies.

Country programme evaluations (CPEs) provide an assessment of the performance and impact of IFAD-supported activities in a given country. CPEs provide concrete building blocks for reviewing and formulating new country strategic opportunities programmes (COSOPs) in individual countries. CPEs also contribute to IFAD's policy dialogue with other development agencies and government representatives concerning rural and agricultural development.

Project evaluations. IOE has traditionally conducted two types of project evaluations:

- **Interim evaluations,** which are mandatory before starting a further project phase or launching a similar project in the same region. Findings and recommendations are used to assess the justification for a further phase in a given country and for improving the design and implementation of subsequent interventions; and
- **Completion evaluations,** which are normally conducted after the finalization of the project completion report prepared by the borrower and IFAD, with the aim of assessing results and generating lessons for future operations.

New form of project evaluations. As recommended by the Peer Review of IFAD's Evaluation System, starting from 2011, IOE will change its approach to project evaluations and will conduct two types of evaluations, which will fulfil the objectives of project evaluations conducted in the past in terms of accountability and learning:

- **Project completion report validations (PCRVs).** A PCRV is an independent assessment by IOE of each project completion report (PCR) prepared by PMD for a completed IFAD-financed operation. The PCRV will be based on a desk review of documents and interactions with IFAD operations staff and concerned government authorities. It will include an assessment of the overall quality and contents of each PCR, including validation of the ratings across the evaluation criteria.
- **Project performance assessment (PPA).** The PPA will be conducted on a sample of projects for which PCRVs have been conducted in a given year. It consists of further review of documentation and field visits involving meetings with key stakeholders and visits to selected project sites.
