## Proposed provisional agenda of the Evaluation Committee for 2015

- 1. **Background.** As per the Terms of Reference and Rules of Procedure of the Evaluation Committee<sup>1</sup> approved by the Executive Board in May 2011, this document contains the proposed provisional programme of work (hereafter "provisional agenda") for the Evaluation Committee in 2015.
- 2. It is to be noted that rule 2 of the Committee's rules of procedure provides that "the Committee retains the prerogative to revise by adding, deleting, defining or amending items on the agenda during the course of the year."
- 3. **Dates of Evaluation Committee sessions.** The document also proposes dates for the four Committee sessions planned for 2015. The dates have been defined in consultation with the Office of the Secretary in order to avoid overlap with the planned governing body meetings of the two other Rome-based United Nations food and agriculture organizations.
- 4. **Objective.** The proposed provisional agenda will enable the Committee to carry out its role and responsibilities in accordance with the revised IFAD Evaluation Policy and the Terms of Reference and Rules of Procedure of the Evaluation Committee. It seeks to ensure that the Committee has, as in the past, the opportunity to review and comment on the main evaluation reports produced by the Independent Office of Evaluation of IFAD (IOE) and IFAD Management. These reports fall into three categories:
  - (a) Evaluation reports produced annually by IOE and Management, as called for by the IFAD Evaluation Policy as well as the Committee's terms of reference. This category includes the Annual Report on Results and Impact of IFAD Operations (ARRI), the work programme and budget of IOE, the Report on IFAD's Development Effectiveness (RIDE), and the President's Report on the Implementation Status of Evaluation Recommendations and Management Actions (PRISMA):
  - (b) A variety of evaluation reports prepared by IOE, including all corporate-level evaluations, a selected number of country programme and project evaluations, as well as evaluation syntheses; and
  - (c) All corporate operational policy and strategy proposals arising from evaluation lessons and recommendations, including IOE comments on the proposals before they are considered by the Executive Board.
- 5. **Criteria for the selection of evaluations to be presented to the Evaluation Committee.** IOE reviewed past Committee agendas and found that each year the Committee considered all corporate-level evaluations prepared by IOE, two country programme evaluations, and two or three project evaluations. These figures have been taken into account in preparing this provisional agenda.
- 6. **Decision.** The Committee is requested to consider the information contained in the following table, and decide on the proposed dates and agenda for its four planned sessions in 2015. As per its Terms of Reference and Rules of Procedure, the Evaluation Committee may, during the year, decide to hold additional sessions over and above the four planned in 2015 in order to effectively discharge its oversight functions.
