Progress report on implementation of IFAD's Regular Grants Policy


I. Introduction

1. This annual progress report is the fifth following the approval of IFAD's Regular Grants Policy in 2021. The report uses data from corporate reporting systems, grant status reports and quality assurance reviews and is laid out as follows:
 - (i) Section II provides an overview of the regular grant portfolio, based on grant status reports submitted in 2024.
 - (ii) Section III provides an update on regular grants approved during the period of the Twelfth Replenishment of IFAD's Resources (IFAD12) (2022, 2023 and 2024) and their quality at design stage, based on the ratings assigned during the quality assurance review process.
 - (iii) The results management framework (RMF), the grants approved by the President under IFAD12, and additional portfolio data are provided in the appendices.

II. Overview of the grant portfolio (2024)


2. Grant status reports (GSRs) are submitted annually in March to assess performance across various implementation areas for the previous year. They are prepared for all grants that were ongoing or completed during the reporting period (January to December 2024) and had been under implementation for at least three months, drawing on recipient progress reports and desk-based or on-site supervision. GSRs submitted in March 2025 cover 47 grants, of which 37 were under implementation and 10 were completed in 2024. Only 12 of these were approved under the IFAD12 cycle, including 3 approved in 2024.
3. **Grant portfolio and cofinancing.** The 47 grants correspond to a total of US\$77.8 million in IFAD regular grant financing. In addition, US\$95.9 million in cofinancing was mobilized from domestic and international sources, bringing the total to US\$173.7 million. The cofinancing ratio rose from 0.8:1 in the 2023 (US\$73 million) to 1.3:1, but it remains below IFAD's RMF target of 1.5:1.
4. **Grant recipients.** Figure 1 shows the distribution of grant financing (including cofinancing) across various recipient categories. In 2024, NGOs (not-for-profit) received US\$89.7 million, the largest share of the total portfolio (51.7 per cent), followed by intergovernmental organizations (including United Nations agencies) with US\$27.6 million (15.9 per cent) and research institutions (including academic institutions and CGIAR centres) with US\$25.6 million (14.7 per cent). Multi-stakeholder platforms accounted for US\$19.6 million (11.3 per cent), while membership-based organizations (i.e. farmers' and producers' organizations) received US\$3.0 million (1.7 per cent). Government institutions received US\$2.6 million (1.5 per cent), private sector organizations US\$2.4 million (1.4 per cent), foundations/trusts US\$2.3 million (1.3 per cent) and Indigenous Peoples' organizations US\$0.8 million (0.5 per cent). Recipient performance was strong, with 95 per cent of grants rated moderately satisfactory or higher (between 4 and 6), and an average rating of 4.6.

5. **Overall implementation progress.** Grant implementation is monitored under results area 2 of the policy's RMF on implementation effectiveness, using ratings from the GSRs (see appendix I). The 2024 results are presented against the end-replenishment targets and illustrated in figure 2. Overall, grant implementation performance has been positive. In 2024, 93 per cent of grants were rated moderately satisfactory (4) or above, with an average rating of 4.5, slightly higher than in 2023 when 90 per cent of grants received similar ratings. Of the 47 grants considered, only 2 were rated moderately unsatisfactory (3). For these, Management is taking follow-up action to improve performance. In a limited number of cases, no rating was assigned as the necessary information was not yet available. While implementation performance has been assessed positively overall, 24 of the 47 grants required no-cost extensions, still largely due to the disruptions and implementation delays that affected the cohort of grants that was under implementation during the COVID-19 pandemic.

6. **Mainstreaming themes.** The GSRs revealed robust performance in addressing mainstreaming themes across grants in 2024. While 95 per cent of grants were rated moderately satisfactory (4) or higher on mainstreaming overall, performances varied by theme:

- (i) **Gender** has been effectively embedded in project design and implementation with 95 per cent of the 39 gender-mainstreamed grants having ratings of moderately satisfactory or higher. This reflects consistent attention to gender-responsive design and implementation across the grant portfolio.
- (ii) **Nutrition** was a thematic focus for 32 grants. Of these, 84 per cent received at least a moderately satisfactory rating, up from 81 per cent in 2023. A recent evaluation led by the Independent Office of Evaluation of IFAD on nutrition¹ underscores that grants have played an important role in strengthening IFAD's nutrition priorities. Grants financed studies, specialist expertise and partnerships with CGIAR centres, the Food and Agriculture Organization of the United Nations (FAO) and leading universities, generating knowledge that contributed to strategic discussions on nutrition mainstreaming. At country level, grants promoted behaviour change campaigns and smallholder trainings that complemented larger loan-funded projects. IFAD will build on and strengthen further such synergies between grants and the investment portfolio to foster more systemic and sustained linkages across the overall portfolio.
- (iii) **Environment and natural resource management** featured in 39 grants, with 97 per cent rated moderately satisfactory or above. This performance underscores the effectiveness of interventions on climate resilience and biodiversity conservation.
- (iv) **Youth** inclusion performed equally well: of the 39 grants integrating youth-related activities, 97 per cent had moderately satisfactory ratings or better.
- (v) **Indigenous Peoples** are not specifically tracked though the GSRs. However, the sixth cycle of IFAD's grant-funded Indigenous Peoples Assistance Facility (2022–2026) primarily promoted community-level biodiversity conservation and climate resilience and was rated as satisfactory (5).

7. **Potential for scaling up.** The potential for scaling up has been assessed positively across the 2024 portfolio, with 95 per cent being rated as moderately satisfactory or higher with clear pathways for replication, institutional adoption and resource mobilization.

8. **Partnerships.** In 2024, 31 grants (65 per cent) supported strategic IFAD partnerships, all rated moderately satisfactory. Of these, 35 per cent focused on influencing policy and development priorities, 26 per cent on knowledge and innovation, 16 per cent on enabling coordinated country-led development

processes, 10 per cent on strengthening private sector engagement, 6 per cent on enhancing visibility and 6 per cent on leveraging financial resources.

9. **Effectiveness at completion.** For the 2024 reporting period, effectiveness at completion demonstrated positive results, with 95 per cent of grant proposals rated as moderately satisfactory or above, against the RMF target of 80 per cent.

III. Grants financed under the IFAD12 regular grants programme envelope and way forward

10. The following section provides a brief overview of the regular grants financed in 2022, 2023 and 2024, and their design quality ratings in terms of their alignment with IFAD's Regular Grants Policy (appendix III).
11. **Grants approved in IFAD12.** A total of US\$29.3 million was committed under IFAD12 to 29 regular grants. With US\$53 million in cofinancing, or US\$1.64 leveraged for every dollar in grants approved, IFAD exceeded its cofinancing target of 1.5:1. They include 19 standard grants (US\$24.1 million), and 10 contribution grants (US\$5.2 million) in support of initiatives that play a critical role in advancing IFAD's policy engagement and contribution to global policy dialogue and strategic partnerships. In addition to these, IFAD also repurposed US\$2.0 million in 2022 to support the IFAD Fund for Gaza and the West Bank, and US\$929,990 was committed to 28 microgrants in 2024 (i.e. grants below US\$50,000). Thus, IFAD approved a total of US\$32.3 million in grant resources under IFAD12. In terms of cofinancing under IFAD12, the portfolio achieved a cofinancing ratio of 2.5:1, well above the RMF target.

12. **Grant beneficiary selection.** Under IFAD12, only 6 of the 19 recipients of standard regular grants (32 per cent) were selected competitively against a forecasted 70 per cent. This was primarily due to (i) six grants being approved as second- or third-phase operations, building on well-performing initiatives from previous cycles, and (ii) the withdrawal of seven grant proposals from the pipeline between July and October 2024 owing to the risk of delays in delivery, with the corresponding resources committed within the IFAD loan pipeline. Building on the lessons from the IFAD12 experience, Management has strengthened the grant selection process for the IFAD13 grants pipeline to ensure that key priorities are taken into account, and that sufficient time is allocated to deliver a grant pipeline with a majority of recipients being selected competitively. As a result, 75 per cent of grants planned under IFAD13 are expected to be awarded through a competitive selection process, marking a significant improvement over the previous cycle.
13. **Quality at entry.** As indicated in RMF results area 1 concerning relevance and alignment with the Regular Grants Policy, all proposals approved under IFAD12 have been rated as moderately satisfactory (4) or higher in terms of overall quality; ownership, country focus and contribution to corporate priorities; synergies and linkages; and knowledge, innovation and scaling up. The proposals have been fully aligned with IFAD's corporate priorities, strategic objectives (SOs), and priority

areas (PAs) as outlined in the Regular Grants Policy (SOs and PAs are further elaborated below).

14. **Strategic objectives.** According to the grants policy, the regular grants programme has two mutually reinforcing strategic objectives:
 - (i) SO1: Leverage better impact on the ground for IFAD's programme of work, including through improvement of in-country capacity for greater sustainability of benefits; and
 - (ii) SO2: Foster a more conducive policy and investment environment for smallholder agriculture and rural development, including at the regional and global level.
15. The policy requires that most of the resources available must be allocated to activities focused on the achievement of SO1. Table 3 shows that the allocation of resources to SO1 in 2022, 2023 and 2024 is in line with the grant policy.

16. **IFAD12 priority areas.** Priority replenishment commitments, or PAs, establish the thematic focus for each replenishment cycle and are approved by the Executive Board. Under IFAD12, five priority areas were defined: PA1: mainstreaming and targeting; PA2: strategic focus on fragility, conflict and building resilience; PA3: strategic partnerships; PA4: enhancing performance and efficiency; PA5: sustainability and scaling up results. Further information is provided in table 4 below.

IV. Conclusions and way forward

17. The grant portfolio demonstrated overall satisfactory implementation on all key performance indicators and contributed to key strategic priorities, including on mainstreaming themes, partnerships, innovation, and knowledge management. Quality at entry remained strong, reflecting alignment with IFAD's Regular Grants Policy and demonstrating strong ownership, relevance, synergies with the investment portfolio and targeting. Moreover, grants approved during IFAD12 leveraged US\$2.5 in cofinancing for every dollar invested by IFAD.
18. To further leverage the strategic contribution of grants to enhancing IFAD's impact, Management has implemented proactive measures to strengthen supervision and oversight of IFAD's grant portfolio during IFAD13. These include: (i) a refined process for strategically selecting grant projects to ensure alignment with all corporate priorities; and (ii) the development of a grants system to optimize key processes and facilitate reporting. Collectively, these initiatives are intended to further enhance the effectiveness of grants in promoting innovation, supporting strategic partnerships, and bolstering IFAD's overall development impact.
