

Launch of the MOPAN report on IFAD

How can findings from the MOPAN assessment of IFAD support the successful implementation of IFAD13?

CONTEXT

The report presenting MOPAN's assessment of IFAD, led by Canada, Finland and France, will be launched on 15 February at IFAD headquarters in Rome. MOPAN assessments identify strengths and areas for development in different areas of organizational management. The assessments are global public goods and aim to support organizational learning and accountability, and inform discussions between multilateral organizations and their stakeholders.

OVERVIEW

The MOPAN assessment of IFAD recognizes the **critical role that the agency plays in the multilateral system**. The assessment highlights IFAD's importance in addressing major global challenges: supporting disadvantaged rural communities to adapt and be resilient to climate change; improving global, regional and local food security; and supporting highly marginalized people.

As IFAD develops plans to implement the Thirteenth Replenishment of IFAD's Resources (IFAD13), this launch event will **share key findings and reflect on how they can be used to further enhance IFAD's results and impact**. Members of IFAD's Executive Board and senior staff will share their views about how findings from the assessment can support the successful implementation of IFAD13.
