MEMBERSHIP OF THE EXECUTIVE BOARD

1. The Governing Council, at its Twentieth Session, elected the following List B Member States as Members and Alternate Members to the Executive Board:

<u>List B</u>	<u>Member</u>	<u>Alternate Member</u>

	Saudi Arabia	Indonesia
	Venezuela	Algeria

2. It was decided that, during the one-year period between the Twentieth and Twenty-First Sessions of the Governing Council, the List B Membership could be modified to include any ineligible member which might acquire eligibility to the Executive Board during this period. The Governing Council is asked to note that the Federal Republic of Nigeria has since acquired eligibility to sit on the Executive Board. Subsequently, the List B Members of the Executive Board reformulated their composition as follows:

3. During the elections at the Twentieth Session, agreement was reached in List C by Sub-Lists C1 and C2 Member States with regard to the exchange of seats on the Executive Board. It was decided that, with respect to the agreements reached at the Twentieth Session amongst the Sub-Lists C1 and C2 Member States on the exchange of seats, any subsequent changes within the official term of office would require Governing Council endorsement. The endorsement of the Governing Council is therefore sought with regard to the following exchange of seats within the Sub-Lists C1 and C2 Countries:

4. Accordingly, with the endorsement by the Governing Council of the change in the seats for Sub-Lists C1 and C2 as set out in paragraph 3, representation on the Executive Board for 1998 will be the following:
