Report on the status of contributions to the Sixth Replenishment of IFAD's resources

1. For the information of the Governing Council, the present document contains the following annexes:
 - Annex I Summary of the status of contributions to the Sixth Replenishment as at 31 January 2007
 - Annex II Status of contributions to the Sixth Replenishment as at 31 January 2007
 - Annex III Status of complementary contributions to the Sixth Replenishment as at 31 January 2007
2. As shown in the summary table in annex I, total pledges to the Sixth Replenishment, including complementary contributions, amounted to US\$509.1 million equivalent as at 31 January 2007, representing 91 per cent of the replenishment target of US\$560 million equivalent.
3. The table in annex I also shows that collectively, including complementary contributions, at 31 January 2007 instruments of contribution deposited with the Fund and payments not supported by instruments of contribution amounted to the equivalent of US\$468.8 million equivalent or 92 per cent of pledges. Total payments received in cash or promissory notes for the Sixth Replenishment amounted to US\$446.6 million equivalent or 88 per cent of pledges.
4. Annex II shows the details of Member States' contributions to the Sixth Replenishment as at 31 January 2007, excluding complementary contributions.
5. Annex III shows the details of complementary contributions to the Sixth Replenishment as at 31 January 2007. The aggregate pledged or paid complementary contributions of Belgium, Canada, India, Luxembourg and the United Kingdom of Great Britain and Northern Ireland amounted to US\$28.9 million equivalent, of which US\$21.1 million equivalent – or 73 per cent – had been received.
6. Member States whose instruments of contribution or payments for the Sixth Replenishment have not yet been received by IFAD are kindly requested to take the necessary measures as soon as possible.
