<sup>&</sup>lt;sup>1</sup> In 1992 the Socialist Federal Republic of Yugoslavia (SFRY) was dissolved. At its Forty-Seventh Session (Rome, 1-4 December 1992) the Executive Board did not permit any of the republics of the former SFRY to continue, or succeed to, the membership of SFRY in the Fund. As provided by Article 9 Section 3 of the Agreement Establishing IFAD whenever a State ceases to be a Member it shall have no rights under the Agreement Establishing IFAD. Following clarification by international jurisprudence, all calculations and allocations of votes among Member States, including in the table provided above, have been done in accordance

with Article 6 Section 3 of the Agreement Establishing IFAD. In the computation the SFRY is disregarded, as no voting rights can be attributed to a Member which no longer exists.

<sup>&</sup>lt;sup>2</sup> The Governing Council approved the membership of the Republic of the Marshall Islands at its thirty-second session. As a Member State of IFAD, the Republic of the Marshall Islands is entitled to membership votes in accordance with Article 6, Section 3(a) of the Agreement Establishing IFAD.
