## Report on the Eighth Replenishment of IFAD's resources

1. **Adoption.** Resolution 154/XXXII on the Eighth Replenishment of IFAD's Resources was adopted by the Governing Council on 19 February 2009. The period of the Eighth Replenishment is defined in the resolution as "the three-year period commencing 1 January 2010 and ending on 31 December 2012".
2. **Target.** Paragraph II.3(b) of resolution 154/XXXII established the target level of the Eighth Replenishment at US\$1.2 billion. Paragraph II.3(c) of the resolution specified that the structural gap between total pledges and the target level may not exceed fifteen per cent (15 per cent). As indicated in paragraph 3 below, pledges as at 19 August amounted to US\$1,043,382,330, corresponding to 86.9 per cent of the US\$1.2 billion target. Accordingly, the President of IFAD has communicated to all Members of the Fund that the target level of the Eighth Replenishment is confirmed at US\$1.2 billion.
3. **Pledges.**<sup>1</sup> Pledges made as at the date of adoption of the resolution, i.e. 19 February 2009, amounted to US\$940,434,693, including complementary contributions. As at 19 August, pledges amounted to US\$1,043,382,330, including complementary contributions.
4. **Additional pledges.** As at 31 December 2009, pledges to the Eighth Replenishment amounted to US\$1.057 billion equivalent, corresponding to 88 per cent of the Eighth Replenishment target of US\$1.2 billion. Member States that have not yet pledged and those intending to increase their contribution are urged to communicate their pledges to the Fund as soon as possible.
5. **Instruments of contribution.** As at 31 December 2009, instruments of contribution deposited amounted to US\$575 million or 55 per cent of pledges as at 19 August 2009. Member States whose instruments of contribution have not yet been deposited are requested to take the necessary action as soon as possible.
6. **Payments.** As at 31 December 2009, payments received from Member States for the Eighth Replenishment totalled US\$278 million equivalent, or 26 per cent of pledges.
7. **Status of Contributions.** Annexes I and II set out the status of pledges, instruments of contribution deposited and payments in cash and promissory notes for the Eighth Replenishment, as at 31 December 2009.
8. **Effectiveness.** In accordance with paragraph II.8(a) of resolution 154/XXXII, the Eighth Replenishment would become effective on the date "upon which the Instruments of Contribution relating to contributions from all the Members have been deposited with the Fund in the aggregate total amount equivalent to at least fifty per cent (50 per cent) of the total contribution to the Replenishment of all such Members". On 1 December 2009, Instruments of Contribution and payments not supported by Instruments of Contribution had been deposited in an aggregate amount of US\$564 million or 54 per cent of total pledges of US\$1.043 billion as at 19 August 2009, and the Eighth Replenishment was declared effective.
9. **Creation of new votes.** Under the voting system introduced on 20 February 1997 by resolutions 86/XVIII and 87/XVIII, new votes are created for each replenishment. These votes are allocated on a basis similar to the original and replenishment votes and

are divided between membership and contribution votes. As resolution 154/XXXII provided that votes for the Eighth Replenishment would be calculated on the basis of aggregate pledges received within the six months following the resolution's adoption on 19 February 2009, i.e. by 19 August 2009, paragraph IV.20 of the resolution could not be completed at the time of the resolution's adoption.

10. Of the total pledges of US\$1,043,382,330 received as at 19 August, pledges amounting to US\$69,856,657 were in the form of complementary contributions, pledged in accordance with paragraph II.4(d) of resolution 154/XXXII, and thus did not count towards the creation of votes. This resulted in a balance of US\$973,525,673 for the creation of Eighth Replenishment votes.

11. Under the formula stipulated in article 6, section 3(a)(ii) of the Agreement Establishing IFAD, 100 replenishment votes are created for every US\$158 million of convertible currency contributions pledged. Thus, for the Eighth Replenishment, the amount of US\$973,525,673 created 616.155 replenishment votes, broken down into membership votes and contribution votes. The total of the Eighth Replenishment votes is fixed and will not be altered by any change in the membership of the Fund or further pledges to the Eighth Replenishment.

12. Paragraph IV.20 of resolution 154/XXXII has been completed as follows (the text added is underlined), as contained in revised resolution 154/XXXII:

**"Allocation of New Votes for the Replenishment**

In accordance with section 3(a)(ii) of article 6 of the Agreement, six hundred and sixteen point one five five (616.155) new votes are hereby created for the Replenishment ("Eighth Replenishment Votes"). Those votes shall be distributed as follows:

- (a) **Membership Votes.** Two hundred and fifty-eight point six nine one (258.691) votes shall be allocated as membership votes, with each Member receiving an equal number of the said votes. Upon any change in the number of Members of the Fund, two hundred and fifty-eight point six nine one (258.691) votes shall be redistributed upon the same basis. Column D-1 of attachment C to this resolution, as it may be amended from time to time, specifies the current distribution of Eighth Replenishment Membership Votes.
- (b) **Contribution Votes.** The remaining three hundred and fifty-seven point four six four (357.464) votes shall be allocated as contribution votes to each Member in the proportion that each Member's paid contribution, valued in United States dollars at the effective rate for the Replenishment, to the additional contributions made under the Replenishment, as specified in paragraph II.4(a) of this resolution and as amended by paragraph II.4(b) of this resolution, bears to the aggregate of the total contributions made by all Members to the Replenishment. For that purpose, a paid contribution shall be deemed to be only the part of a contribution of a Member actually paid to the Fund, in accordance with paragraph IV.20 of this resolution. Column D-2 of attachment C to this resolution, as it may be amended from time to time, specifies the potential Eighth Replenishment contribution votes for each Member if all Members pay the pledges specified in column B-2 of attachment A to this resolution. Column D-3 of attachment C to this resolution, as it may be amended from time to time,

specifies the actual Eighth Replenishment contribution votes of each Member.

- (c) **Effectiveness.** The allocation of the six hundred and sixteen point one five five (616.155) votes, as specified in provisions (a) and (b) above, shall enter into effect upon the date on which the period specified in paragraph II.4(b) of this resolution shall come to an end.”
13. Accordingly, the membership and contribution votes became effective as from 19 August 2009. The current status of Member States’ votes, showing both membership and contribution votes and including Eighth Replenishment votes as at 31 December 2009, is attached to this report as annex III. Although the number of Eighth Replenishment votes is fixed at a total of 616.155, the distribution of contribution votes among Member States will change as payments of contributions are received. Therefore, all Member States contributing to the Eighth Replenishment, including those announcing their pledges after 19 August 2009, will receive a share of the Eighth Replenishment contribution votes in proportion to their respective share of paid-in contributions to the replenishment.

If the final target is revised downwards, the Netherlands reserves the right to lower its pledges accordingly, in order not to exceed its percentage share of 6.25 of the target.

<sup>j</sup> The contribution of US\$50 million by Saudi Arabia consists of US\$20 million as Saudi Arabia's core contribution to the Eighth Replenishment and US\$30 million as a complementary contribution to the replenishment, to be utilized to increase food production in low-income countries.

<sup>k</sup> Sweden's additional contribution will not exceed SEK 360 million and should correspond to no more than 5.4 per cent burden share of the total pledged. Sweden has also pledged a complementary contribution of SEK 100 million for both grant financing and enhancement of the design and implementation of regular IFAD projects and programmes, with the goal of increasing food security in the least developed countries.
