## Report on the status of the Ninth Replenishment of IFAD's Resources

1. **Reporting requirement.** Resolution 166/XXXV on the Ninth Replenishment of IFAD's Resources was adopted by the Governing Council on 22 February 2012. The period of the Ninth Replenishment is defined in the resolution as "the three-year period commencing 1 January 2013 and ending on 31 December 2015". Pursuant to section XI of resolution 166/XXXV the present report concerns the status of commitments, payments, the Ninth Replenishment votes and other relevant matters concerning the Ninth Replenishment of IFAD's Resources.
2. **Target.** Section I(b) of resolution 166/XXXV established the target for additional contributions and special contributions from non-Member States at the amount of US\$1.5 billion. Section I(e) of resolution 166/XXXV establishes a structural gap to be observed at the end of a six month period after the adoption of the resolution. The structural gap between total pledges and the target level may not exceed fifteen per cent (15 per cent). As set forth in annexes I and II, pledges, instruments of contributions and paid contributions as at 22 August amounted to US\$1,403,713,444, corresponding to 94 per cent of the US\$1.5 billion target. Accordingly, the President of IFAD has communicated to all Members of the Fund that the target level for additional contributions and special contributions is confirmed at US\$1.5 billion.
3. **Status of Contributions.** Annexes I and II set out the status of pledges, instruments of contribution deposited and payments in cash and promissory notes for the Ninth Replenishment, as at 31 December 2012.
  - (i) **Pledges** made as at the date of adoption of the resolution, i.e. 22 February 2012, amounted to US\$856 million including complementary contributions. As at 31 December 2012, pledges amounted to US\$1,386 million including complementary contributions. The amount at year end reflects additional commitments made since February 2012 as well as the firming up by certain governments of the provisional figures originally provided for indicative purposes as pledges.
  - (ii) **Instruments of contributions.** As at 31 December 2012, instruments of contribution deposited amounted to US\$1.0 billion or 71 per cent of pledges as at 22 August 2012. Member States whose instruments of contribution have not yet been deposited are requested to take the necessary action as soon as possible.
  - (iii) **Payments.** As at 31 December 2012, payments received from Member States for the Ninth Replenishment totalled US\$406 million equivalent, or 29 per cent of pledges.
4. **Ninth Replenishment votes.** In accordance with article 6, section 3(ii) of the Agreement Establishing IFAD, replenishment votes shall be made up of votes to be decided by the Governing Council upon each occasion that it calls for additional contributions. Accordingly, in section IX (a) of resolution 166/XXXV the Governing Council decided that new replenishment votes shall be created ("Ninth Replenishment votes"). The Governing Council also decided that the total amount of Ninth Replenishment votes shall be calculated by dividing the total amount of pledges to core contributions, which have been received as of 22 August 2012 by US\$1,580,000.
  - (i) **Creation of new votes.** Of the total pledges of US\$1,403,713,444 received as at 22 August, pledges amounting to US\$357,958,776 were in the form of complementary contributions, pledged in accordance with section III(a)(ii) of

resolution 166/XXXV, and thus do not count towards the creation of votes. This results in a balance of US\$1,045,754,668 of core contributions for the creation of Ninth Replenishment votes. Under the formula stipulated in article 6, section 3(a)(ii) of the Agreement Establishing IFAD, and section IX (a) and (b) of resolution 166/XXXV, 100 replenishment votes are created for the equivalent of each US\$158 million contributions pledged. Thus, for the Ninth Replenishment, the amount of US\$1,045,754,668 creates 661.870 replenishment votes.

- (ii) **Distribution of the new votes.** In accordance with article 6, section 3(a)(ii) of the Agreement Establishing IFAD, and section IX (a) and (b) of resolution 166/XXXV the Ninth Replenishment votes are broken down into membership votes and contribution votes. The total of the Ninth Replenishment votes is fixed and will not be altered by any change in the membership of the Fund or further pledges to the Ninth Replenishment. A table containing the calculation of membership and contribution votes, including Ninth Replenishment votes, is attached hereto as annex III. Although the number of Ninth Replenishment votes is fixed at a total of 661.870, the distribution of contribution votes among Member States will change as payments of contributions are received. Therefore, all Member States contributing to the Ninth Replenishment, including those announcing their pledges after 22 August 2012, will receive a share of the Ninth Replenishment contribution votes in proportion to their respective share of paid-in contributions to the replenishment. Annex III presents the voting rights of Member States as at 31 December 2012.
5. **Effectiveness of the replenishment.** In accordance with section V(a) of resolution 166/XXXV, the Ninth Replenishment will become effective on the date "upon which the Instruments of Contribution relating to the additional contributions and special contributions from States referred to in section III of this resolution 166/XXXV have been deposited with or received by the Fund in an aggregate amount equivalent to at least fifty per cent of the pledges as communicated by the President to Members pursuant to section I(e)." There are Members that make direct payments without depositing an instrument of contribution. On 30 November 2012, Instruments of Contribution and payments not supported by Instruments of Contribution had been deposited in an aggregate amount of US\$741 million or 53 per cent of total pledges of US\$1.4 billion as at 22 August 2012, and the Ninth Replenishment became effective.
6. **Effectiveness of the new votes.** In accordance with section V(c) of resolution 166/XXXV, the distribution of the Ninth Replenishment votes shall enter into effect six months after the adoption of the resolution. Accordingly, the Ninth Replenishment votes became effective as of 22 August 2012.
