Report on the status of contributions to the Ninth Replenishment of IFAD's Resources

1. For the information of the Governing Council, the present document contains the following annexes:
 - Annex I Summary of the status of contributions to the Ninth Replenishment as at 12 December 2013
 - Annex II Status of Member States' contributions to the Ninth Replenishment as at 12 December 2013
2. As shown in the summary table in annex I of this report, total pledges as at 12 December 2013, including complementary contributions, amounted to US\$1,395 million equivalent, corresponding to 93 per cent of the Ninth Replenishment target of US\$1.5 billion. Member States that have not yet pledged and those intending to increase their contribution are urged to communicate their pledges to the Fund as soon as possible.
3. Annex II shows the details of individual Member States' contributions to the Ninth Replenishment as at 12 December 2013.
4. As at 12 December 2013, instruments of contribution deposited amounted to US\$1,269 million making up 90 per cent of total pledges. Member States whose instruments of contribution have not yet been deposited are requested to take the necessary action.
5. As at 12 December 2013, payments for the Ninth Replenishment received from Member States amounted to US\$799 million equivalent, or 57 per cent of pledges.
6. During the same period, for IFAD8, pledges received amounted to 90 per cent of the Replenishment target, instruments of contribution deposited amounted to 83 per cent and payments received amounted to 57 per cent of the level of pledges; for IFAD7, pledges received amounted to 89 per cent of the Replenishment target, instruments of contribution deposited amounted to 84 per cent and payments received amounted to 41 per cent of the level of pledges.
