Report on the Status of the Tenth Replenishment of IFAD's Resources

1. For the information of the Governing Council, the present document contains the following annexes:
 - Annex I Summary of the status of contributions to the Tenth Replenishment (as at 31 December 2017)

2. As shown in the summary table in annex I of this report, total pledges as at 31 December 2017 amounted to US\$1.1 billion equivalent, including core and unrestricted complementary contributions. In addition, Member States pledged US\$2.9 million as contributions to the Debt Sustainability Framework.
3. As at 31 December 2017, instruments of contribution deposited amounted to US\$1.05 billion making up 95 per cent of total pledges received. Member States whose instruments of contribution have not yet been deposited are requested to take the necessary action.
4. As at 31 December 2017, payments for the Tenth Replenishment received from Member States amounted to US\$860 million equivalent, or 78 per cent of pledges.
