TOAST TO THE INTERNATIONAL
YEAR OF THE WOMAN FARMER

The forty-ninth session of the Governing Council of IFAD (GC49) takes place over two days. The first day, Tuesday, 10 February, is the High-level Segment of the Governing Council with Leaders' Dialogues, while the second day, Wednesday, 11 February, is focused on matters related to governance and partnership.

The formal session will be preceded on Monday, 9 February, by a pre-event day. It will bring together a wide range of partners and offer opportunities for bilateral meetings among delegates and with IFAD Management and staff. **A Briefing Session on Governance at IFAD** will give an overview of IFAD's governance framework, decision-making in IFAD's governing bodies and the roles and engagement of Member States in defining the Fund's strategic direction. The session will also provide information on the proposed implementation of an electronic in-presence and closed voting system at IFAD, which may be used for the appointment of the President of IFAD at the fiftieth session of the Governing Council in February 2027, if required.

HIGH-LEVEL SEGMENT. This will feature keynote addresses, a Centre Stage Event and Leaders' Dialogues with special high-level guests. The first day will conclude with a special event marking the 10th anniversary of the Governing Council's adoption of the International Day of Family Remittances.

GOVERNANCE AND PARTNERSHIPS. There will be a forward-looking focus on IFAD throughout the second day, which will include the consideration of business items, the annual Governors' Roundtable, an exploration of priorities for the upcoming Consultation on the Fourteenth Replenishment of IFAD's Resources (IFAD14), Governors' Dialogues and other events that celebrate the power of partnerships.

IFAD fulfils a unique role in rural transformation as an innovative specialized agency of the United Nations and an international financial institution that promotes and invests in rural areas and rural women, youth and men to render them prosperous, equitable and resilient contributors to national growth.

The overarching theme of the Governing Council is "**From Farm to Market: Investing with Young Entrepreneurs**". There are 1.3 billion young people in the world today – the largest generation in history, and nearly half of them live in rural areas. These young women and men face deep challenges: limited access to land, finance, skills and decent jobs, while climate change and migration pressures weigh heavily on their communities. Yet they also represent one of the greatest untapped

opportunities of our time. With their energy, resilience, and openness to innovation, youth are already reimagining agriculture and food systems: adopting digital solutions, driving green transitions and reshaping value chains from farm to market.

IFAD recognizes that youth are not just the future, they are the present. By investing in their entrepreneurial potential, we can unlock new pathways for employment, reduce poverty and inequality, and ensure that rural areas become thriving engines of stability, prosperity and sustainable growth.

This session takes place at the beginning of the **International Year of the Woman Farmer**, declared in recognition of the key role that women farmers around the world play in agrifood systems and their contributions to food security, nutrition and poverty eradication. It comes at a time when we need to redouble our efforts to address the root causes of fragility, conflict and forced migration and overcome the discrimination and challenges faced by rural youth and women farmers so that they may realize their potential as drivers of economic and social development and transformed rural areas.

IFAD remains committed to fostering innovation and sustainable growth by investing in rural people and transforming rural economies. Women make up more than half of IFAD's project participants, while over 60 per cent of our active project portfolio is youth-sensitive, reaching more than 12 million young people globally. We firmly believe that empowering youth and women entrepreneurs to initiate and expand agribusinesses will serve as a vital catalyst for economic development and create lasting positive impacts. By investing in the next generation of innovative farmers and entrepreneurs, we aim to build resilient, inclusive economies that benefit all.

The forty-ninth session of the Governing Council will also mark the **establishment of the IFAD14 Consultation** and provide a forum for Governors to share their insights on priority areas for strategic action. This discussion will continue at the **launch of the IFAD14 Consultation** on Thursday, 12 February, with Consultation members.

IFAD14 REPLENISHMENT

In accordance with the Agreement Establishing IFAD, Member States periodically review the Fund's performance and agree on its future priorities and resource requirements. The Consultation on the Fourteenth Replenishment of IFAD's Resources will be formally established at this forty-ninth session of the Governing Council, after which an initial discussion will take place among Consultation members. The IFAD14 Consultation will determine the level of ambition for the Fund's programme of work in the 2028-2030 period. Three formal sessions will be held over the course of 2026 and the Consultation's recommendations will be captured in the IFAD14 Report, which will be submitted to the Governing Council for endorsement at its fiftieth session, in February 2027.

INTERNATIONAL YEAR OF THE WOMAN FARMER 2026

In recognition of the United Nations' declaration of 2026 as the International Year of the Woman Farmer – a global observance celebrating the vital contributions of women farmers to food security, climate resilience and rural prosperity – this high-level dialogue will spotlight women farmers as leaders, innovators and entrepreneurs driving resilient and inclusive rural economies. Together, we will honour their leadership and commitment to building stronger, more profitable and sustainable rural livelihoods.

MAXIMIZING THE IMPACT OF REMITTANCES AND DIASPORA INVESTMENT ON RURAL DEVELOPMENT

The International Day of Family Remittances (IDFR) was adopted by IFAD's Governing Council in 2015 and by the United Nations General Assembly in 2018. Since then, it has become a global movement endorsed by public and private actors alike. Over the past decade, migrants have sent over US\$5 trillion to low- and middle-income countries, one third of which reaches rural areas. Through remittances, diaspora investment and support to returning migrants, IFAD has led global efforts to turn the story of migration from one of departure into one of opportunity and development at home. Supported by donors and partners, IFAD's Financing Facility for Remittances has channelled these flows into financial inclusion, climate resilience and rural prosperity. The IDFR embodies this shared commitment, uniting all actors to make every remittance count for development.

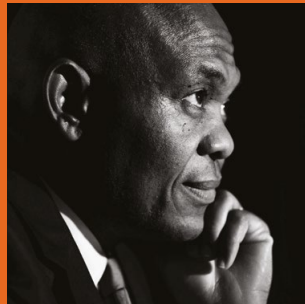


MARY ROBINSON

Mary Robinson is the co-founder of Project Dandelion, a women-led global campaign for climate justice, and a founding member of The Elders, an independent group of global leaders founded by Nelson Mandela in 2007. She was the first woman to hold the office of President of Ireland, serving the country from 1990 to 1997.

She was subsequently appointed United Nations High Commissioner for Human Rights and held that position from 1997 to 2002.

From 2013 to 2016, she served as Special Envoy of the United Nations Secretary-General, first on the Great Lakes Region of Africa, then as Special Envoy on Climate Change until the adoption of the historic Paris Agreement on Climate Change in 2015, and finally as Special Envoy on El Niño and Climate.



TONY ELUMELU

Tony O. Elumelu is an African investor, philanthropist, and one of the most prominent voices on Africa's transformation agenda.

He is the Founder and Group Chair of Heirs Holdings, a family-owned investment company, investing in financial services, power, technology, healthcare, energy and hospitality.

Tony Elumelu is the Chair of the United Bank for Africa, which operates in 20 African countries and in France, the United Arab Emirates, the United Kingdom and the United States.

In 2010, he founded [The Tony Elumelu Foundation](#) (TEF), Africa's leading philanthropic organization driving entrepreneurship across all 54 African countries. TEF has funded over 24,000 entrepreneurs and built a digital ecosystem valued at US\$100 million that has reached 2.5 million Africans.

A TIME100 honouree (2020), Tony Elumelu holds national honours from Nigeria and Gabon, as well as Belgium's oldest royal order. He serves on global boards including UNICEF Generation Unlimited and the IMF Advisory Council on Entrepreneurship and Growth.
